# President's Corner – Rick Boyles

Thanks to all who participated in the Molly and Danny Howlett July 4<sup>th</sup> parade. They had an outstanding turn out and it looks like everyone had a good time. Also, thanks to all who picked up the American flags I put out at the end of my driveway and placed them on your street. As you could tell, they were donated by a local politician, but they were free!

There are a couple of important issues to be aware of to discuss at the July 17, 2023, meeting:

Big Issue #1-Selection of a new voting system. We have a court mandated 10 – 1 City Council District Voting system (10 Districts where the Council Member is elected only by voters in that District) imposed during the last Council election cycle. That system violates the City Charter (which is derived from State Law) and must be changed by the State Legislature in 2024. The ultimate question is going to be whether to keep the 10 -1 system or move to something else such as a 7 - 3 - 31 system (where there are 7 Districts with Council members elected only by people in those Districts, with 3 "superward" Districts made up of parts of the 7 Districts. The question becomes: Do you want 11 Council Members to push their decision on the Richmond lawmakers or should the issue be put in front of the taxpaying, voting public to say which voting system will be used for the foreseeable future?

### Big Issue #2-Possibly "moving" the Green Line-Project Wayne

At last report, the City Attorney was directed by City Council to work with a medical device manufacturing company to prepare a rezoning request for taxpayer owned land below the Green Line, which would require the company to disclose their name. The City and the private company would be co-applicants for a rezoning of this property located in the ITA/Transition area. This rezoning has the potential to set a legal precedent in that land-use decisions must be fair to all who apply. If rezoning is allowed for one, then it must be allowed for others, opening the door to further development of agricultural land south of the Green Line. We believe that the next time we hear about this is going to be when it is in front of the Planning Commission. This question becomes: Should we allow a rezoning of land south of the Green Line or do we hold to the promises made by City Councils over the past 44 years to not install water, sewer, roads, curbs, and gutters (service infrastructure)?

News Channel 3 was alerted to the flag and reached out for comment. While we find the wording on the flag distasteful and something that we would prefer not be out for children to see, this is not an issue in which the Thalia Civic League would be involved.

We fully support anyone's right to voice their political opinions and hope that we all can do so in a more civilized manner. The driver of the vehicle remained on scene and was cooperative with first responders. This accident is being investigated by the Virginia Beach Police Department Traffic Safety Unit.

Parks After Dark was created to help establish a safe space for fun and family-friendly activities during evening hours when there are often fewer activities available for teens.

#### Make an Emergency Plan

Make sure everyone in your household knows and understands your hurricane plan. Ensure your business has a continuity plan to continue operating when disaster strikes.

#### **Know your Evacuation Zone**

You may have to evacuate quickly. Learn your evacuation routes, practice with your household and pets, and identify where you will stay. Follow the instructions from local emergency managers,



who work closely with state, local, tribal, and territorial agencies and partners. They will provide the latest recommendations based on the threat to your community and appropriate safety measures.

#### **Review Important Documents**

Make sure your insurance policies and personal documents are up to date. Make copies that you can

take with you and keep a set in a secure passwordprotected digital space.

### Gather Supplies

Have enough supplies for your household, including medication, disinfectant supplies and pet foods and medications in your go bag or car trunk. You may not

have access to these supplies for days or even weeks after a hurricane.

### Strengthen your Home

De-clutter drains and gutters, bring in outside furniture, and consider hurricane shutters.

Get Tech Ready

When a storm comes, keep a full charge on your mobile phone and have backup charging devices to power electronics.

#### Help your Neighborhood

Check with neighbors, senior adults and anyone who may need additional securing hurricane plans to see how you can be of assistance to others
