

BOROUGH OF CLINTONVILLE, YENANGO COUNTY, PENNSYLVANIA

ORDINANCE NO 94-1

AN ORDINANCE OF THE BOROUGH OF CLINTONVILLE, YENANGO COUNTY, PENNSYLVANIA, PROVIDING FOR ENTERING INTO AN INTERGOVERNMENTAL COOPERATION AGREEMENT WITH THE BOROUGH OF EMLENTON, YENANGO COUNTY, PENNSYLVANIA, FOR THE PURPOSE OF THE PROVISION OF LAW ENFORCEMENT SERVICES BY THE BOROUGH OF EMLENTON, YENANGO COUNTY, PENNSYLVANIA, FOR THE BOROUGH OF CLINTONVILLE, YENANGO COUNTY, PENNSYLVANIA.

WHEREAS, the Borough of Clintonville and the Borough of Emlenton, both situate in Yenango County, Pennsylvania, desire to enter into an Intergovernmental Cooperation Agreement for the purpose of the Borough of Emlenton providing law enforcement services to the Borough of Clintonville utilizing the police force of the Borough of Emlenton and providing for compensation for the rendition of such services; and

WHEREAS, said municipalities, for the purpose of carrying the provisions of the Intergovernmental Cooperation Act, Act of July 12, 1972, No. 180 P.L. 762, as amended (53 Pa. C.S.A. 481, et seq.) into effect, deem it appropriate to enter into such Agreement; and

WHEREAS, said municipalities have determined that the residents of such municipality will be best served by the provision of law enforcement services by the Borough of Emlenton to the Borough of Clintonville, through the Police Department of the Borough of Emlenton, rather than having two separate police forces in each of the respective municipalities.

NOW THEREFORE, BE IT ORDAINED AND ENACTED by the Council of the Borough of Clintonville, Yenango County, Pennsylvania, and it is hereby Ordained and Enacted by the authority of and pursuant to the provisions of the aforesaid Intergovernmental Cooperation Act, and pursuant to the authority and provisions of the Borough Code, Act of February 1, 1966, P.L. 1656, No. 581, as amended (53 Pa. C.S.A. 45101, et seq.)

SECTION 1 - TITLE. This Ordinance shall be known as the Emlenton Borough-Clintonville Borough Joint Municipal Law Enforcement Ordinance.

SECTION 2 - PARTIES. The Borough of Clintonville hereby resolves to enter into an Intergovernmental Cooperation Agreement with the Borough of Emlenton, whereby Clintonville shall delegate, transfer and confer upon the Borough of Emlenton certain functions, powers and responsibilities of the Borough of Clintonville by entering into a Joint Municipal Agreement for Law Enforcement Services.

SECTION 3 - PURPOSE. The purpose of the Joint Municipal Agreement for Law Enforcement Services is to have the police department of the Borough of Emlenton perform law enforcement functions within the Borough of Clintonville under the terms and conditions set forth therein.

SECTION 4 - CONDITIONS OF AGREEMENT. The conditions of the Joint Municipal Agreement for Law Enforcement Services to be entered into between the participating municipalities are generally as follows:

A. The Borough of Emlenton shall provide to the Borough of Clintonville through the police department of Emlenton law enforcement services within the cooperate limits of the Borough of Clintonville, which services shall be of similar nature as that provided for the Borough of Emlenton, including enforcement of the Vehicle Code, Crimes Code, Ordinances of the Borough of Clintonville, security checks and patrols, reporting

hazardous conditions, investigative services, prosecution in court cases, and administrative reporting services.

B. The rendition of the aforesaid police services shall be made by the police department of the Borough of Emlenton as Emlenton Borough employees and under and subject to the control, supervision and direction of Emlenton Borough, with the mayors of each borough coordinating the services to be rendered, provided however, that Emlenton Borough shall be responsible for workers' compensation, liability insurance and the provision of all necessary equipment.

C. The Borough of Emlenton shall be compensated for the provision of said police services to the Borough of Clintonville on an hourly basis as agreed upon from time to time between the parties, initially being at the rate of Fourteen Dollars (\$14.00) per hour.

D. For the purpose and objective of providing law enforcement services in Clintonville Borough by Emlenton Borough, Clintonville Borough delegates its police power to Emlenton Borough.

E. The Joint Municipal Agreement for Law Enforcement Services shall remain in full force and effect on an annual basis, however, shall be subject to termination by either borough at any time upon such borough giving the other thirty (30) days advance written notice of said termination date.

F. Any and all real and personal property necessary for the rendition of said law enforcement services shall be purchased, owned by, and licenses in the name of Emlenton Borough.

SECTION 5 - REPEAL OF INCONSISTENT RESOLUTIONS AND ORDINANCES

ALL RESOLUTIONS AND ORDINANCES, OR PARTS OF EITHER, which are inconsistent herewith, are hereby repealed to the extent of such consistency.

SECTION 6 - INVALIDITY


The invalidity of any part of this Ordinance.


SECTION 7 - EFFECTIVE DATE

This Ordinance shall become effective upon enactment by the Borough Council of the Borough of Clintonville, Venango County, Pennsylvania, and enactment of a companion ordinance by the Borough of Emlenton, Venango County, Pennsylvania, and the finalization of a Joint Municipal Agreement for Law Enforcement Services by both Boroughs.


