The expo will be located on both sides of I Street between 11th and 12th Streets. Booth spaces will be allocated on a first-come/first served basis. Reservations will be confirmed upon receipt of signed application.

Peace Officer Memorial Run Vendor Agreement

- 1. Booths must be set up by 6:00 a.m. Sunday, October 6th, 2024 and must remain open until the race concludes (approximately 12 p.m.). At 12 p.m., vendors must remove all booth materials and merchandise. The expo is located on both sides of I Street between 11th and 12th Streets.**
- 2. Booth spaces will be allocated on a first-come/first-served basis. Reservations will be confirmed upon receipt of signed contract.**
- 3. POMR will try to honor booth location requests; however, we reserve the right to make reasonable changes to requests as space is limited.**
- 4. The Peace Officer Memorial Run Committee reserves the right to reject a vendor booth.**
- 5. Vendors will provide their own tables and chairs and whatever else is needed for inside the assigned space.**
- 6. Vendors are allowed to use pop-up tents (canopy) or other display systems. Canopies larger than 10X10 are prohibited unless express arrangements have been made with the Safety Faire/Run Expo Coordinator.**
- 7. The Peace Officer Memorial Group is not responsible for lost, stolen or damaged merchandise.**
- 8. Vendors may display signs or materials; however, they may not extend beyond booth boundaries.**
- 9. Peace Officer Memorial Group, Inc., and their representatives, reserves the right to use any video, audio, or any photographic media obtained at the event for promotional purposes.**
