Riverside High School Circa 1938

Bob Zigman, Riverside Class of 1938, was kind enough to send us an accounting of his recollections of the history of the school. For instance, Bob discovered from archives of the "Mercury" that "Milwaukee High School", the forerunner to the current Riverside University High School, was the only High School in Milwaukee in 1892. Milwaukee West Division and Milwaukee South Division had not yet been built. The first mention of Riverside's school colors, orange and black, was in the December, 1893 edition of the Mercury where students were encouraged to wear these colors.

Other tidbits: Most of Riverside's teachers in the early days had Ph.D. degrees and were called "Professor"; A notice in the November, 1892 School Newspaper read – "Anyone who brings us information as to who sets the Assembly clock ahead every day will be suitably rewarded"; In the early days, male members of the faculty actually played on the school's football team; The enrollment in 1900 was 471 students, 252 boys and 219 girls. Note: In 2009-10, the total enrollment was 1,580 of which 781 were female and 799 were male.

Scholarship Winners Are Off to School

Thanks to the generosity of the Foundation donors, we were able to distribute thirty-seven scholarships this past year to deserving graduating seniors. These one-time grants included thirty-four (34) in the amount of \$500, one at \$750 and two at \$1,000. Although these amounts will hardly make a dent in the cost of college for most of these students, they are a recognition that these students did what we told them that they had to do to be successful at Riverside and they made it! The gratitude of these students is reflected in the many "Thank-you" letters that we received from the students. Common among the comments were the following: "I greatly appreciate the scholarship and want to thank-you for helping me in my journey into college life. It is a true blessing that someone would invest this much money in my future!" "I want to assure you that this money is a sound investment in my future. I won't let you down". "Thanks to the academic preparation I received at Riverside and with the financial support of the Foundation and others, I believe that I have a bright future ahead of me and I can't tell you how excited I am with the possibilities and how anxious I am to get started on the next phase of my life".

2010 Flood Damage

In July, 2010, Riverside suffered one of its most destructive natural disasters ever in the form of the severe rain storm and flooding. As the adjacent pictures demonstrate, the entire lower level of the newer part of the building under the new gym and the pool was completed destroyed. An entire computer lab, the whole band/orchestra area, several art rooms and



much more were completely wiped out. The floors of the "old gym" downstairs in the older portion of the building had to be completely replaced. Nearly \$6.5 Million dollars in damage in all will be covered by the District's insurance. What will not be covered are the personal teaching supplies of teachers. Lesson plans, mementoes, tests, grade books, art projects, pens, pencils, computer software, computer storage disks, file cabinets, student photos, family pictures, college diplomas, were all destroyed. The Foundation would like to be able to provide each teacher affected in these ways by the flood with



a nominal amount of money to replace such items. Please consider giving an extra \$10, \$15 or \$20 for the Foundation's "Flood Relief Program". The faculty will decide how this money can best be disseminated to the teachers who lost personal teaching items in the flood.
