- **Minimum rental fee is \$55.00 plus tax and restocking.**
-
- No Restocking on **Jewelry** or **Shoes**, Walkabouts are 30% of rental rate
- Weekend restocking is 45% of rental rate.
- Used and/or wrinkled garments must be returned dry-cleaned
- Wardrobe not returned within the approval period will be charged full rental rate whether used or not.
- Rental returns are one week from order date.
- Rental periods longer than 1 week are billed accordingly; Every 6 week interval is charged an additional 25% extended rental.
- Multiple sets are not to be broken without Costume Department consent.
- **Loss & Damage will be charged at 5 TIMES the replacement value listed**

- Features, TV, Commercials, and Web Series – 48 hours • Restocking charges of \$4.00 per unused item on orders Mon – Thurs
- Weekend restocking charges are 45% of the items rental rate.

HAVE THE VALUE AS STATED ON THE INVENTORY SHEETS, AND THAT IN THE EVENT THAT ANY ITEMS ARE LOST OR DESTROYED TO THE EXTENT THAT SUCH ITEMS CANNOT (IN STUDIO'S SOLE OPINION) BE UTILIZED, RENTER AGREES TO PROMPTLY PAY TO STUDIO THE STATED VALUE OF ANY SUCH LOST OR DESTROYED ITEMS
