CONSTITUTION

PREAMBLE

WHEREAS prayer is the means by which we reach the presence of God to influence the hearts of people;

WHEREAS the world is in dire need for true intercessors who shall stand in the gap for God on behalf of peoples, lands and nations;

LET IT BE ANNOUNCED that we, the united-nations of prayer warriors, enthusiasts, lovers and children of God the Father, from all tribes, races, ethnicities, cultures and ages, have come together to pray for the world, virtually, and where possible, physically, for discerned and requested needs, without discrimination or recrimination, but in faith with joy and love for people and God, we stand;

AND TO OURSELVES give this, a "One World under Prayer" vision, and commit ourselves to freely, voluntarily and dutifully pray for the world.

I. NAME

The name of the organization shall be called **Intercessors International Inc**. or (3Is), and shall be a virtual prayer organization headquartered wherever its current leader is located.

II. AIM

The organization shall have only one aim, to pray for the whole world.

III. OBEJECTIVES

The organization has the following three objectives:

- a) To recruit people who shall pray for the world
- b) To provide timely, well-researched and relevant prayer requests for prayer
- c) And to actually pray through all prayer requests provided

IV. ORGANIZATION

The organization shall be a virtual organization, and may meet physically from time to time and only when it is necessary. The organization of **3Is** shall be as follows:

- a) There shall be a Leader who is the founder of the organization and who for the time of their life on earth shall provide leadership, set vision and lead its members, supporters, volunteers, and adherents into prayers. The Leader shall remain for life and shall only be succeeded upon his death by an election facilitated by the Executive Committee (EC) to elect a successor from among the EC members.
- b) There shall be an Executive Committee comprising:
 - i. The Leader the Chief Executive Officer
 - ii. The Vice-president the organization's chief operation and recruiting officer
 - iii. The Social-Media and Virtual Laison Officer the publicity manager of the organization
 - iv. The Chief Financial Officer the organization's accountant
 - v. The Head of Research & Development (R&D) the organization's researcher and prayer research facilitator

At a bare minimum, all EC members must at least believe in the Apostles Creed.

V. FINANCES

The organization shall raise finances through membership fees, donations and projects. The finances raised by the organization shall be for the purposes of:

- a) Running the operations of the organization
- b) Remuneration of full-time workers of the organization
- c) Purchasing equipment and other facilities as may be needed from time to time
- d) Conducting R&D and for printing manuals and materials

VI. PRAYER MANAGEMENT

The organization's prayer tripartite management model shall be as follows:

- a) The Lord's Prayer Model
- b) The Bridging the Gap Model
- c) The Needs-First Model

The tripartite model shall be the basis upon which all requisitions are laid and shall govern the choice of requests and order of prayer.

VII. MEMBERSHIP

Membership to the organization is open to anyone who agrees with the constitution and philosophy of 3Is. The organization shall have two types of memberships:

- a) Open Membership everyone person who can pray, loves to pray or desires to pray may hold an open free membership
- b) Vetters Membership an annual fee paying and renewable membership and only Vetters (paid-up members) can vote and be elected to the EC.

VIII. VOLUNTEERS

The organization's main operation front is through volunteers, who shall be recruited from across the globe to conduct chain prayers, targeted prayers, world prayer cells, and prayer rallies to pray for the world.

IX. PRAYER PHILOSOPHY

Unless it is a prayer rally or otherwise designated as a "Public Prayer," by the EC, all prayers shall be conducted in secret (privately) in obedience to the Lord's command. Names of members and volunteers shall not be published publicly and everyone is free to post on social media their prayer requests, needs, and feelings for members and volunteers to pray for. However, the organization may not share the particulars of individual prayer requesters or the members and volunteers who prayed for those requests.

X. GLORY MODEL

The organization's success model is the "Glory Model," and unless it gives glory to God, it is neither permitted nor successful. Testimonies shall be strictly governed by the principle of *good faith* and *bona fides*. The honor, praise and glory of God shall together be the primary motive for giving any prayer testimony.
