FEES AND TUITION RATES FOR THE 2023-2024 SCHOOL YEAR

- Registration Fee TK-8th \$250.00 per student, due with enrollment form. (NON-REFUNDABLE)
- Book Fee for K-8: \$300.00 per student (NON-REFUNDABLE, Includes \$50 Yearbook fee)
- Book Fee for TK: \$180.00 per student (NON-REFUNDABLE, Includes \$50 Yearbook fee)
- Activity Fee: \$150.00 per student (Kindergarten-8th grade)
- Technology Fee: TK-K: \$100 per student. 1st-8th : \$200 per student
- Parent Club Fee: \$440.00 per family, billed July-May (11 months) @ \$40 per month.
- Camp Keep Fee (6th Grade only): \$500.00 per student, billed July-October (4 months) @\$125.00 per month.
- Graduation Fee (8th Grade only): \$350.00 per student billed July-April (10 months) @ \$35.00 per month.
- Family Hours REQUIREMENT: 20 hours per family are required (\$500) billed July-April (10 months) @ \$50 per month. Hours served will be credited. If hours have been paid for before earned, the credit will be applied towards tuition.
