 - Hold a Bachelor's degree from an accredited college or university.
- **REQUEST** an interview with the principal at the school at which you wish to substitute teach.

If you are hired, the following must be submitted before starting to work:

- A clear criminal record from the DOJ and FBI
- Proof of citizenship or immigration status to verify your right to work in the U.S. (I-9 form)
- A signed copy of your Job Offer document
- A signed copy of the Safe Environment "Code of Conduct"
- A signed receipt of the "Classified Personnel Manual" on the "Diocese of Fresno Receipt of Classified Personnel Manual Acknowledgement" form
