**Summary Annual Report for the  
Indiana Laborers Welfare Fund**

This is the summary annual report for the Indiana Laborers Welfare Fund , EIN 35-0923209, Plan number 501 for the period December 1, 2021 to November 30, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

**Insurance Information**

The plan has a contract with insurance carriers to pay claims incurred under the terms of the plan. See attached list of carriers. Total premiums paid during the plan year were \$2,198,730.

Because they are so-called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending November 30, 2022, the premiums paid under such "experience-rated" contracts were \$1,654,312, and the total of all benefit claims paid under these "experience-rated" contracts during the plan year was \$1,600,188.

**Basic Financial Statement**

The value of plan assets, after subtracting liabilities of the plan, was \$280,303,791 as of November 30, 2022, compared to \$274,452,040 as of December 1, 2021. During the plan year the plan experienced an increase or (decrease) in its net assets of \$5,851,751. This increase or (decrease) includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$101,363,429 including employer contributions of \$103,272,879, employee contributions of \$7,962,524, realized gains or (losses) of \$-12,766,089 from the sale of assets, and earnings from investments of \$757,676.

Plan expenses were \$95,511,678. These expenses included \$9,994,230 in administrative expenses, \$85,517,448 in benefits paid to participants and beneficiaries, and \$0 in other expenses.
