Capacity Reserve

- Hallow Energy is deploying a marketing exercise to attract raw materials trading companies with the commercial, financial and logistical capabilities to reserve capacity (full or partial) at the Puerto Quetzal Maritime Terminal.
- A preselection was made of companies that met at least one of the following criteria:
 - ÿ that carry out operations in Central America;
 - ÿ that carry out operations in the Pacific;
 - ÿ technical, commercial and financial solvency to reserve capacity; and
 - ÿ that Hallow Energy has professional contact with its managers.
- A universe of companies that met these requirements was identified and they were contacted. We have had introductory calls and shared the *Teaser* and commercial information about the Guatemalan hydrocarbon market.
- Throughout meetings and calls, we have found great commercial interest and appetite for the project in leading companies in the sector, who have requested more market information, which has been generated and delivered.
- We have detected interest not only in the Capacity Reserve, but also in other phases of the business, such as the construction of the terminal, its operation or the distribution of fuel within the country.

- Of the 25 companies or groups of investors contacted, there are 8 that have shown greater interest;
 Hallow Energy has continued to share information about the project with the aim of obtaining Letters of Intent (LOI).
- The 8 companies with the greatest interest, in addition to having international operations, enjoy high prestige in the marketing of raw materials.
