## LEASE CONTRACT WITH TRANSSHIPPING WORLD COMPANY, S.A. JD-08-90-2023

THE UNDERSIGNED SECRETARY OF THE BOARD OF DIRECTORS OF THE PORT QUETZAL COMPANY, CERTIFIES: That having reviewed the Book of Ordinary and Extraordinary Sessions of the Board of Directors of the Port Quetzal Company, in which point Eight (8th) of the minute number ninety (90) dated December 16, 2023, of the Ordinary Session, which copy of the resolution part literally says: JD NINETY ZERO EIGHTY EIGHT THOUSAND TWENTY-THREE (JD-08-90-2023). CONSIDERING: That by means of the Agreement of the Board of Directors number JD ninety one four sixty seven thousand twenty-three (JD-04-60-2023) dated August 16, 2023, which was modified by means of the Agreement of the Board of Directors number JD ninety ten sixty seven thousand twenty-three (JD-10-67-2023) dated September 12, 2023, this collegiate body agreed:

- I. Authorize the subscription of a lease contract for the area of seventy-six thousand one hundred forty-four point eighteen square meters (76,144.18 m²) located in the fourth zone (4) of the Port Precinct in favor of the entity TRANSSHIPPING WORLD COMPANY, SOCIEDAD ANÓNIMA, which will be destined for the passage of pipes, ridges, flexible from the monobuoy to the fuel and other liquid bulk storage and distribution terminal. Likewise, for the arrangement of valves and measuring station, for the contractual term of twenty-five (25) years counted from the day following the actual delivery of the property, which must be recorded by means of Administrative Act, in accordance with the conditions established by the Technical Commission in the opinion number DICT dict com guión thirty and three thousand twenty-three (DICT-COM-33-2023) dated August 16, 2023.
- **II.** The General Manager is instructed to coordinate with the entity Transshipping World Company, Sociedad Anónima, to carry out the necessary steps before the competent entities, in order to enable the construction and operation of the fuel storage and distribution terminal.
- **III.** Instruct the General Management and the Legal Advisory Unit to continue with the corresponding procedures for the formalization of the respective contract.

**IV.**Set a period of sixty (60) working days from the day following the notification of this agreement, for the formalization of the respective contract; in case of non-compliance, Empresa Portuaria Quetzal reserves the use or disposition of the area without any prejudice.

**V.** Instruct the Legal Advisory Unit to include in the contract to be signed for the formalization of the present authorization, that the entity Transshipping World Company, Sociedad Anónima, is obliged to comply with any modification that is made in relation to the cost of the rent contained in the Internal Regulations to Regulate and Authorize the Use and Utilization of the Port Space, Maritime and Terrestrial Services of the Port Quetzal Company; as well as the provision of services.
