The main problem was that we all liked to ride around town quite fast and we were a problem for the police as they couldn't always catch us but they knew where we congregated and got us all together and made an offer to help train us to be better riders if we worked with them to produce training videos and so the journey to sitting the IAM test began.

In later years I took the opportunity of doing the Bikesafe training and enjoyed my day out with police officers so on a trip to the bike show in Edinburgh and visit to the IAM stand the decision was made to do the IAM coaching and test.

I had concerns about my own ability half way through the coaching and wondered if I could do everything that was being asked of me to meet the standards required for the test but on the day I passed with a F1RST. Getting such a great result gave me a real 'buzz' on the way home and also made me want to give something back to the group and decided I wanted to become an observer and that decision led me to becoming more involved with the group. I enjoyed coaching associates and went on to do the national test and become a local observer assessor but at the same time I had also decided to join the committee as group secretary and then took on the role of group chair.

The group chair's role is all about ensuring the group runs smoothly and conforms to the guidelines set by the IAM and we are lucky that we have a core of members on the committee who give their time to make that happen. Lindsay as treasurer, Belinda as group secretary, Mark as membership secretary, and Kenneth who does fantastic work producing the newsletter. The group also wouldn't function without the time and effort given by the other committee members, chief observers, and observers.

The one thing that I have enjoyed is the feeling of respect within the group and its members, a respect for what we have done and what we do and we should all be proud of that as it's something I feel is lacking in some areas of society today.
