**ORDINANCE TO ADOPT COMPREHENSIVE PLAN**

**SECTION I - TITLE AND PURPOSE.**

The title of this ordinance is the Town of Seneca Comprehensive Plan Ordinance. The purpose of this ordinance is for the Town of Seneca, Crawford County, Wisconsin, to lawfully adopt a comprehensive plan as required under sec. 66.1001(4)(c), Wis. Stats.

**SECTION II – AUTHORITY.**

The Town Board of the Town of Seneca, Crawford County, Wisconsin, has authority under its village powers under sec. 60.22, Wis. Stats., its power to appoint a town plan commission under sec. 60.62(4) and sec. 62.23(1), Wis. Stats., and under sec. 66.1001(4), Wis. Stats., to adopt this ordinance. The comprehensive plan of the Town of Seneca must be in compliance with sec. 66.1001(4)(c), Wis. Stats., in order for the town board to adopt this ordinance.

**SECTION III - ADOPTION OF ORDINANCE.**

The Town Board of the Town of Seneca, Crawford County, Wisconsin, by this ordinance, adopted on proper notice with a quorum and roll call vote by a majority of the Town Board present and voting, provides the authority for the Town of Seneca to adopt its Comprehensive Plan under sec. 66.1001(4), Wis. Stats., and provides the authority for the Town Board to order its publication.

**SECTION IV - PUBLIC PARTICIPATION.**

The Town Board of the Town of Seneca has adopted written procedures designed to foster public participation in every stage of the preparation of a comprehensive plan as required by sec. 66.1001(4)(a), Wis. Stats.

**SECTION V - TOWN PLAN COMMISSION RECOMMENDATION.**

The Plan Commission of the Town of Seneca, by a majority vote of the entire commission, recorded in its official minutes, has adopted a resolution recommending to the Town Board the adoption of the Town of Seneca Comprehensive Plan, which contains all of the elements specified in sec. 66.1001(2), Wis. Stats.

**SECTION VI - PUBLIC HEARING.**

The Town of Seneca has held at least one public hearing on this ordinance, with notice in compliance with the requirements of sec. 66.1001(4)(d), Wis. Stats.

**Section VII Penalties**

Wisconsin state boating penalties as found in Wisconsin Statute 30.80, and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, are hereby adopted by reference and all references to fines amended to forfeitures and all references to imprisonment deleted.

**Section VIII Severability**

The provisions of this Ordinance shall be deemed severable and it is expressly declared that the Town Board would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected.


**Section IX Effective Date**
