AN ORDINANCE AMENDING THE ORDINANCE TO ESTABLISH RULES, REGULATIONS, AND SPECIFICATIONS FOR THE CONSTRUCTION AND/OR ACCEPTANCE OF PRIVATE ROADS IN THE TOWN OF SENECA, CRAWFORD COUNTY, WISCONSIN

The Town of Seneca, Crawford County, Wisconsin, does ordain as follows:

WHEREAS, the Town of Seneca, Crawford County, Wisconsin, has enacted an Ordinance to Establish Rules, Regulations and Specifications for the Construction and/or Acceptance of Private Roads in the Town of Seneca, Wisconsin, on the 5th day of August, 1999; and

WHEREAS, said ordinance has been effect since the posting of said ordinance in accordance with Wisconsin Statutes; and

WHEREAS, the Town Board has now determined that public safety and the public interest requires an amendment to the definition of "private drives, private roads" so as to ensure emergency ambulance, fire, and police vehicles have safe, convenient and reasonable access to all residences located within the Town of Seneca, Crawford County, Wisconsin; and

WHEREAS, said Town Board now wishes to amend the definition;

NOW, THEREFORE, the Town Board of the Town of Seneca, Crawford County, Wisconsin, does ordain as follows:

The definition of "private drives, private roads" found in Section 2 of the Ordinance to Establish Rules, Regulations, and Specifications for the Construction and/or Acceptance of Private Roads in the Town of Seneca, Crawford County, Wisconsin, is hereby amended to read as follows:

Private Drives, Private Roads - any road, of any length, which has been built by private interests and which serves one (1) or more residential units or a place of business intended to be open to the general public, such as a restaurant, retail store, etc. regardless of the continued private ownership and maintenance of the road, shall be subject to the terms of this ordinance.

This amendment to Section 2 definition section of the August 5, 1999 Ordinance to Establish Rules, Regulations, and Specifications For the Construction

and/or Acceptance of Private Roads in the Town of Seneca, Crawford County, Wisconsin, is effective immediately.

All other provisions of the August 5, 1999 Ordinance to Establish Rules, Regulations, and Specifications For the Construction and/or Acceptance of Private Roads in the Town of Seneca, Crawford County, Wisconsin, remain in full force and effect.

This ordinance shall be known as "Ordinance Amending the Ordinance to Establish Rules, Regulations, and Specifications For the Construction and/or Acceptance of Private Roads in the Town of Seneca, Crawford County, Wisconsin.

This ordinance shall become effective upon passage and the day after posting in accordance with Wisconsin Statutes.
