Commissioner Reilly made a motion to appoint Joey Hayes as new pension trustee for the HNFD Firefighters Pension Trust, 2nd by Commissioner Cooper. Vote held. Motion – passed unanimous.

New Business

- 1. **Resolution 25-01/25-02** As the resolutions were sent over by the attorney several hours before the meeting, Chief Lewis would like to look them over before presenting them. They will be tabled until the next meeting.
- 2. Appointment of new commissioner/Appointment of new chairman Due to the passing of Chairman Stone last month, we are in need of a new Board commissioner. Cameron Cupples, a local firefighter and Navarre resident, is interested in being appointed. Official appointment to the Board and Oath of Office will happen at next month's meeting. Dee will get an email set up for him. Commissioner Cooper nominated Commissioner Culberson to be Chairman, 2nd by Commissioner Reilly. Commissioner Culberson nominated Commissioner Cooper to be Vice Chair and Commissioner Reilly remain Secretary/Treasurer, 2nd by Commissioner Culberson. Votes held. Motions passed unanimous.

Because we would like to also include a dedication to Chairman Stone at the opening, we will coordinate with the Stone family for a convenient time and date.
