## **OWNERSHIP AND REGISTRATION:**

The Breeder guarantees they are the legal owner of the puppy and have the right to sell it. The Breeder will provide all necessary registration documents, if applicable, within a reasonable time after purchase. If registering the puppy with AKC, FDSB/UKC or NAVHDA, the buyer agrees to use "**TriSetters**" as the prefix for the dog's registered name.

## **TRANSFER OF OWNERSHIP:**

Ownership transfers upon receipt of full payment.

The Buyer agrees to:

- Provide a safe, suitable, and loving environment for the puppy throughout its lifetime, including proper shelter, nutrition, and veterinary care (including vaccinations, deworming, and heartworm prevention).
- Never abandon, surrender, or place the animal in a shelter, humane society, rescue, or foster home.

If, for any reason, the Buyer is unable to keep the puppy, the Breeder must be notified first. Please see the Return Policy below for further details.

## **HEALTH GUARANTEE:**

The Breeder certifies that the puppy is in good health at the time of sale and has received age-appropriate vaccinations and deworming. A health record will be provided to the Buyer.

No health guarantees are made after eight (8) weeks of age, except for any known health concerns disclosed prior to contract execution, which are noted here: \_\_\_\_\_

**The Buyer agrees to:**

- Have the puppy examined by a licensed veterinarian within 10 business days of taking possession.
  - If the veterinarian certifies the puppy as medically unfit within this period, the Buyer may:
    - Return the puppy for a full refund of the purchase price, or
    - Retain the puppy and receive reimbursement for reasonable veterinary expenses, up to the purchase price, with proper documentation.
- Activate Trupanion\* 30-day medical coverage (provided at no cost) within 24 hours of taking possession. (details provided in the puppy take-home folder).
- If registering with AKC, activate AKC's 30-day complimentary medical coverage (details provided in the puppy take-home folder).

## **SPAY/NEUTER AGREEMENT:**

This puppy is being sold with **limited registration**. These dogs may be kept as pets and shown, but are not to be bred.

- The Buyer agrees to pay the Breeder \$5,000 for every litter produced by this dog without full registration rights.
- The Breeder is not obligated to allow registration of such litters.
- If the Buyer wishes to obtain full breeding rights later, an additional \$2,000 and/or pick puppy and health testing will be required.
- Approval for full registration is not guaranteed and will be considered on a case-by-case basis.

## RETURN POLICY:

If, for any reason, the Buyer cannot keep the puppy:

- The **Breeder must be notified first**.
- The Breeder retains **first right of refusal** and may choose to take the puppy back and/or assist with rehoming.
- **No refund** will be provided unless mutually agreed upon in writing.
- The Buyer agrees the animal shall **never be abandoned, surrendered, or rehomed** without the Breeder's written consent.
- Unauthorized rehoming will result in a **\$2,000 fine** and the Buyer will be responsible for any costs incurred by the Breeder to locate or retrieve the dog.

## GOVERNING LAW & JURISDICTION:

The Contract shall be governed and interpreted in accordance with the laws of Illinois.

## ENTIRE AGREEMENT:

This document constitutes the entire agreement between the Breeder and Buyer. No other warranties, promises, or representations, verbal or written, are binding unless expressly stated herein.
