Brent has agreed to discuss this with R & R and Supervisor from Miltona and bring info to January meeting. RBS is in agreement to maintain 100% maintenance of these roads, summer and winter, brush/tree and whatever else these roads may need, the billing will be keep separate for Miltona Township. Dale and RBS discussed the wash out at the bottom of driveway as the fire trucks back out of garage. They agreed this area of driveway needs fill, there has already been an issue with snow removal so it will be repaired now.

Motion was made and second to accept and pay all claims with Wade Nibbe, Dale Diedrich and Brent Ost voting aye, no further discussion motion carried.
