The CD in BlackRidge Bank is \$12,548.38 (Fire Fund). There is an income \$25,050.14. Leaf Valley Sportsmen donated \$10,000.00 to assist Fire Dept in cost of drilling new wells. Motion was made and second to accept these reports as prepared and given with Dale Diedrich, Brent Ost and Wade Nibbe voting aye, no further discussion motion carried.

Dale brought the Board up to date on the insurance coverage on the equipment in the basement that is not attached to or on fire trucks, Inland Marine. Motion was made and second with Dale Diedrich, Brent Ost and Wade Nibbe voting aye to set the Inland Marine coverage to not exceed \$100,000.00, not the \$360,000.00 as originally in the first policy, no further discussion, motion carried. Clerk will contact MATIT.

Motion was made and second with Dale Diedrich, Brent Ost and Wade Nibbe to increase the hall rental rate. Effective January 2014 any resident of Township renting hall will pay \$200.00, non-resident \$250.00 and damage deposit will remain@ \$150.00. Any time for any party hall is rented a damage deposit will paid. No further discussion motion carried.

At this time building permits were reviewed. **Treasurer** had all claims ready for Supervisors to review and sign. Motion was made and second to accept and pay checks #8071 to #8084. General Fund totaled \$1,205.26, Road Bridge Fund totaled \$11,782.56, Fire Fund totaled \$9061.39, and Park Fund totaled \$64.34 with all Funds totaling \$22,113.55, no further discussion motion carried.

There was no other Township business needing to be addressed motion was made and second to adjourn with Dale Diedrich, Brent Ost and Wade Nibbe voting aye, no further discussion motion carried. 7:35 P.M.
