Road Engineer and Board discussed the condition of some gravel roads in township and agreed at the road tour these roads would be thoroughly reviewed. All agreed the property around the hall where well was dug needs to be cleaned and after ground settles fire department and supervisors will decide about the changes and driveway project. At this time it was decided the spring road tour will be held on May 08, 2014 @ 8:00 a.m.; a date will be decided then when Board will do a night road sign check. Gary Fuchs had concerns about 4-wheelers tearing up the gravel roads near his residence, discussed with Board how to address situation.

Motion was made and second with Dale Diedrich and Brent Ost voting aye that Brent Ost will be the Chair for the 2014/2015 term and Wade Nibbe will be the Vice Chair for the 2014/2015 term, no further discussion motion carried. Clerk will send necessary notice to banks.

If anyone requests copies of any township minutes or other information individual requesting said information will compensate Board member for time and cost of copies. No further discussion motion carried.

Motion was made and second with Dale and Brent voting aye to continue to compensate all Board members \$60.00 for each monthly meeting, for any Special Meeting, and if they attend any meeting other than at the hall they will be compensated either \$60.00 for 4 hours or \$13.00 an hour, if over 4 hours, mileage will also be paid to & from. No further discussion motion carried.

Motion was made and second with Dale and Brent voting aye to continue to pay the Clerk yearly salary of \$2,000.00 plus per diem; continue to pay the Treasurer yearly salary of \$1,250.00 plus per diem, no further discussion motion carried.

Motion was made and second with Dale and Brent voting aye to continue to compensate Head Election Judges \$13.00 hour for training, election, and mileage. All other election judges will continue to be compensated \$11.00 hour for training, elections and mileage, no further discussion motion carried.

Motion was made and second with Dale and Brent voting aye to meet second Thursday of each month @ 7:00 p.m. @ the L. V. Hall.
