Treasurer transferred \$20,500.00 from savings to checking. Income into the Township for November was \$2,804.55. Motion was made and second to accept this report as prepared and given with Brent Ost and Dale Diedrich voting aye, no further discussion motion carried.

Brad Ruckheim informed Board that there are six (6) people taking the fire training that is offered @ Alex. Tech. The Board and Fire Chief discussed that this spring when landscaping is completed on south side of hall signing is needed around/near well for all vehicles that park and use driveway. This will be addressed at that time.

The Township had great turn out for the General Election, there were 331 registered voters in township, 3 school districts and there were 223 voters and 4 new registered voters.

B & H Builders completed putting white wall board on wall around bar window in lower level. It was agreed by Supervisors that this should be completed on the south and east walls of lower level. Motion was made and second with Brent Ost and Dale Diedrich voting aye to complete this project while the contractor is at hall working. No further discussion motion carried. Clerk will contact B & H Builders of decision by the Board.

At this time Board reviewed and discussed all building permits, mail and all claims the Treasurer had prepared for Supervisors to sign, the claims totaled \$28,600.34. General Fund totaled \$4,216.82, Road/Bridge totaled \$14,477.93 and Park Fund totaled \$9,905.59. Motion

was made and second with Brent Ost and Dale Diedrich voting aye to pay all these claims, no further discussion motion carried.

There was no other Township business needing to be addressed, motion was made and second to adjourn with Brent Ost and Dale Diedrich voting aye. Motion carried.
