Brad introduced new First Responder, Mike Doehling. He had recently completed his training and testing. At this time Brad introduced Scott Korkowski the new Fire Chief for the next 3 year term. Motion was made and second to accept the fire departments recommendation of Scott as new fire chief with Dale Diedrich, Brent Ost and Keith Schultz voting aye, no other discussion motion carried. The new grass rig has all electrical work completed and all fire vehicles have been moved back to fire hall. Brad and Scott informed Board that the two garage doors need to be replaced. They volunteered to get bids and all information for that project and bring information to Board meeting.

RBS and Board discussed condition of gravel roads. A letter to township was received from Ron Bloom, Hidden Valley LN NW with concerns about snow removal. It was addressed and RBS will remove snow with a smaller plow truck because there is no room for large plow truck to turn around at end of road. Joe Wagner and Board reviewed and discussed the **ROAD POLICY** that Township will adopt. Board mentioned this is new for township and each spring all roads are checked but if prior to road tour or at any time due to all traffic on said roads there is any problem Board will contact Joe Wagner. Brent is going to contact resident on Dittberner Creek Rd. informing them that the mailbox which is sitting in 5 gallon bucket, to be

moved and installed correctly. Dale agreed to contact M. Smith MacKenzie to explain and discuss the letter being sent to her, reviewing with her details of letter sent to her. A snow fence will be put up on north side of hall, Stuart Wussow and Jessie Bodell agreed to do it.
