CHAIR, Dale Diedrich called the May 11, 2017 monthly meeting to order @ 7:00 p.m. with the Pledge of Allegiance. Supervisors Brent Ost and Keith Schultz, Treasurer Barb Guenther, Clerk Pam Cuperus, Fire Chief Scott Korkowski and Road Maintenance Engineer Richard Vogt were also present.

CLERK read the minutes of the April 13, 2017 monthly meeting. Motion was made and second to accept minutes as prepared and read with Dale Diedrich, Brent Ost and Keith Schultz voting aye, no further discussion motion carried.

TREASURER gave the financial report since the April 2017 meeting. CD @ BlackRidge Bank is valued @ \$12,768.86 (F.F.); income received into township totaled \$14,543.13. The balance of ALL FUNDS totaled \$665,546.52 and the balance in the checking account was \$1,486.73 on 04/30/2017. The treasurer transferred \$3,000.00 from savings to checking. Motion was made and second to accept this report with Dale Diedrich, Brent Ost, and Keith Schultz voting aye, no other discussion motion carried. The Treasurer continued to prepare checks for Board to review and sign.

The Board reviewed and discussed with RBS Excavating that the roads need to be prepared for chloride application as soon as possible. When the Supervisors did the road tour it was discussed and motion was made and second to apply magnesium chloride on gravel roads where chloride had in past years applied with Dale Diedrich, Brent Ost and Keith Schultz voting aye. Motion carried. There are several other roads in township that also need attention as soon as possible. Richard and Dale agreed to contact each other as each project is started. The cement work on driveway for fire trucks has been completed but there is some work around the edges that need to be finished and around driveway that need attention. The cracking on Hidden Valley will be completed this next week and also the holes filled in, there is a natural spring next to road that has caused damage and Dale will visit with property owner about what needs to be done. There is a sign on Spring Lake Rd. near Alvin Schuck resident it needs to be set back up. It was brought to Boards attention there are a lot of drivers on Spring Lake Rd. near the campground that are driving too fast, the residents of campground want a speed limit sign put up to slow drivers down. The speed limit on township roads is 55 miles per hour. This situation has been discussed with 4 different county road engineers. It is

recommended by the County Highway Dept. to NOT put any signs up on road, having signs on roads are more damaging than nothing.

At this time the Board reviewed mail, building permits and all claims submitted for payment. A motion was made and second to pay claims #8873 to #8887 totaled \$21,964.68; with Dale Diedrich, Brent Ost, and Keith Schultz voting aye, no further discussion motion carried. General Fund was \$5,738.71, Road/Bridge Fund was \$3,344.00 and Fire Fund was \$12,857.97.

There was no other township business needing to be addressed motion was made and second to adjourn with Dale Diedrich, Brent Ost and Keith Schultz voting aye, motion carried. 8:00 pm
