There has been issue with mail boxes when roads are plowed/cleaned by the snow plows. Damage from snow plows very seldom happens when mail box is installed and set up according to the county regulation specifications. It will swing around the regulated post due weight of pushing the heavy wet snow off road, normally NOT knock it down. If a regulated mailbox is damaged by snowplow resident needs to contact snow plow driver or township board member. If the mailbox is not regulation the resident is responsible for setting mail box up and/or repairing mailbox.

The board discussed cost of sanitation service and after reviewing quote from Alex Rubbish motion was made and second to switch service to Alex Rubbish with Dale Diedrich, Brent Ost, and Keith Schultz voting aye, no other discussion motion carried.

The board reviewed sealed quotes received for **2018/2019 Road Maintenance Engineer.** Motion was made and second to accept RBS Excavating information and prices with Dale Diedrich, Brent Ost and Keith Schultz voting aye, no other discussion motion carried.

Motion was made and second for Dale Diedrich to continue as Chair for 2018/2019 term with Brent Ost and Keith Schultz voting aye, no other discussion motion carried.
