Checking account balance 06/30/2018 was \$1,482.81 and CD value remains @ \$12,795.37 (F.F.). Treasurer transferred \$31,000.00 from savings to checking. There was income for township totaling \$184,714.49. Motion was made and second to accept these reports as prepared and given with Dale Diedrich, Brent Ost, and Keith Schultz voting aye no other discussion motion carried. Treasurer continued to prepare checks for Board to review and sign.

This states the yearly contribution will increase from \$1,000.00 to \$1,200.00, effective January 01, 2019 for each fireman actively serving in the department for period of twenty (20) years and all paperwork is handled by PERA. Motion was made and second to accept this **RESOLUTION** and **AMENDMENT** with Dale Diedrich, Brent Ost and Keith Schultz voting aye. Chad and Board discussed the benefits of adopting this resolution, motion carried.

It was agreed that when the dogs are constantly causing problems because of constant barking the local law officials need to be contacted. They will document situation and will discuss it with Jack Lelwica. Board suggested Audie contact Dave Rusch, county level and if need our county commissioner, Keith Englund for further assistance with this situation. Board informed Audie that they are supporting him in this situation.

RBS Excavating and Board discussed three different roads and culverts that are in need of repairs. It was agreed Dale and Richard will go to each of these roads prior to each project getting completed and will decide on exactly where culverts will be replaced.

Dale brought Board up to date regarding Hidden Valley LN. project and his latest visit with Bill Leuthner, attorney. A second letter will be drafted and will be sent to all residents affected by the project informing residents what needs to be done for this project to continue and if residents do NOT respond by specific date project will be abanded and road will go back to gravel. Jeff Stabnow and Dale worked together getting all necessary information for attorney. A public hearing may be needed but everything will be determined once letters have been returned to township. This project will be addressed at next township monthly meeting.

There were couple different residents that have not addressed weed situation on their property. Dale will talk to each of them about this problem.

**Treasurer** had claims prepared for Board to review and sign, #608 to #625; totaling \$79,648.34, General Fund totaled \$2,807.84, Road/Bridge Fund totaled \$73,221.61, Fire Fund totaled \$2,980.15 and Park Fund totaled \$638.74. Motion as made and second with Dale Diedrich, Brent Ost and Keith Schultz voting aye to accept and pay all claims, no other discussion motion carried.

There was no other township business needing to be addressed motion was made and second to adjourn with Dale Diedrich, Brent Ost and Keith Schultz voting aye, motion carried. 8:15 p.m.
