**TREASURER** gave the financial report since the November meeting. There was automatic deposit in November, after the 08<sup>th</sup> monthly meeting totaling \$13,602.69. There is a total of \$129,621.62 income in December. CD @ the BlackRidge Bank value remains @ \$12,795.37 (F.F.); checking account balance on 11/30/2018 was \$16,303.97. Balance of the General, Road/Bridge and Fire Funds on 11/30/2018 was \$601,634.18; Park Fund was \$149.42, Fire Truck Fund was \$16,947.00 and Hall Maintenance Fund was \$38,862.51. The Treasurer transferred \$86,000.00 from savings to checking. Motion was made and second to accept as prepared and read the financial report for December 2018 with Dale Diedrich and Keith Schultz voting aye, motion carried. Treasurer continued to prepare claims for Board to review and sign.

Fire Chief informed Supervisors that half of the fire departments new turn out gear arrived and hopefully in early summer department will be able to purchase remaining needed outfits so entire department will all have new turnout gear. In middle of December entire department will have CPR course so all firemen and first responders will be certified.

Board and road engineer discussed the condition of Vermont Lk. Rd.; due to all truck traffic it needs some blading and if weather conditions hold it will be addressed this next week. Trees and brush throughout township has been addressed, it was agreed to remove tree stumps in spring. There have some comments about the driveways on Hidden Valley Ln and these also will be addressed in spring as weather allows.

Keith will contact Steve Otto, Bremer Bank, and discuss if it would be feasible for township to check into getting a CD.

Board agreed to disconnect ice machine after January rental and leave disconnected until hall is rented during the winter months. Very little ice is used during winter months compared to summer months.
