Treasurer transferred \$93,000.00 from checking to savings. Motion was made and second to accept as prepared and given this financial report with Dale Diedrich, Brent Ost, and Keith Schultz voting aye. Board discussed and decided at this time to NOT transfer any funds into any CD but to continue to monitor the interest rates if they decide to make any changes it can be done anytime. Motion carried. Treasurer continued to prepare checks for the Board to review and sign.

Board and road engineer discussed a couple gravel roads in township that are in need of salt/sand and gravel application due to icy conditions as soon as weather allows.

Fire Chief informed Board fire department received grant money for new washer that as soon as equipment is purchased and invoice sent in the reimbursement around \$8,000.00 will be sent to fire department. Six individuals are taking training and will soon be certified. The fire department decided to roll-over the CD @ BlackRidge Bank, Clerk will contact bank, last truck payment is 2021.

Brent and Keith will be election judges in March for township elections, filings close on 01/15/2019. At this time clerk went over all up-coming meeting dates with Board.

Treasurer had all claims #716 to #736 prepared and ready for Board to review and sign. General Fund totaled \$2,709.36, Road/Bridge Fund totaled \$35,586.29, Fire Fund totaled \$9,172.70 and Park Fund totaled \$869.96, all funds totaled \$48,338.31. Motion was made and second to accept and pay all claims with Dale Diedrich, Brent Ost, and Keith Schultz voting aye, no other discussion motion carried.
