The General, Road/Bridge and Fire Funds totaled \$702,533.96, Park Fund \$2,851.00, Fire Truck Fund \$16,947.00 and Hall Maintenance Fund \$57,861.13 also 01/01/2020. CD @ BlackRidge Bank (F.F.) value is \$13,023.89. Motion was made and second to accept the prepared report as given with Dale Diedrich, Brent Ost and Keith Schultz voting aye no other discussion motion carried. Treasurer continued to prepare checks for Board to review, sign and approve.

Scott Korkowski discussed with Supervisors the CD @ BlackRidge Bank and that there are only two payments left on the fire truck, June of 2020 and 2021. Motion was made and second with Dale Diedrich, Brent Ost and Keith Schultz to cash in CD on January 29, 2020, when it would expire or automatically roll over, contact USDA/RD and in February 2020 make payments and paying off the fire truck debt. No other discussion motion carried. Clerk will contact USDA/RD, BlackRidge Bank, and Scott so at the February meeting Treasurer will know exact amount needed to transfer for final payment. Scott informed Board the new skid unit was installed and delivered and he applied and received a \$5,000.00 grant from DNR. Paper work will be sent in ASAP so the funds will be sent to L.V. Fire Dept.

Mike Doehling representing the First Responders in township inquired about the chance of the organization getting some financial assistance from township with all future training and equipment that is showing its age and will soon need to be replaced and or upgraded. It was recommended that First Responder attend the Annual Meeting in March, at that meeting it can be discussed and hear what other residents suggest and a decision will be made.

All gravel roads continue to be very icy at intersections and some curves so Road Maintenance Engineer will continue to apply gravel where and as needed.

On May 01, 2020 the Leaf Valley Township will rent town hall to the Leaf Valley Sportsmen for the Annual Spring Banquet. Motion was made and second to rent hall to the L.V. Sporstmen's Club for this event on May 01, 2020 with Dale Diedrich, Brent Ost and Keith Schultz voting aye, motion carried.

At this time Board reviewed 2019 weed report and filled it out, it will be sent to county Agriculture Inspector. Board reviewed all invoices, signed all checks #940 to #952. Motion was made and second by Dale Diedrich, Brent Ost and Keith Schultz to pay all of invoices totaling \$42,260.36; General Fund totaled \$2,329.85, Road/Bridge Fund totaled \$30,843.69 and Fire Fund totaled \$9,086.82. No other discussion motion carried.

There was no other Township business needing to be addressed motion was made and second to adjourn with Dale Diedrich, Brent Ost and Keith Schultz voting aye, motion carried. 7:45pm
