CHAIR, Dale Diedrich called the Leaf Valley township monthly meeting to order on March 12, 2020 @ 7:00 p.m. with Pledge of Allegiance. Supervisors Brent Ost and Keith Schultz, Treasurer Barb Guenther, Clerk Pam Cuperus and Road Maintenance Engineer and son, Brad Vogt also was present.

CLERK read the minutes of the February 13, 2020 monthly minutes, after wording correction motion was made and second with Dale Diedrich, Brent Ost and Keith Schultz voting aye to accept as corrected minutes of meeting, no other discussion motion carried. Correction will be made also on web.

TREASURER gave the prepared financial report. Balance on 03/01/2020 in the General, Road/Bridge and Fire Funds was \$645,279.17, Park Fund \$2,571.35, Fire Truck Fund \$16,947.00 and Hall Maintenance Fund \$57,861.13. The checking account balance was \$1,922.91. There was income into township for March 2020 totaled \$24,278.86. Motion was made and second to accept this report as prepared and given with Dale Diedrich, Brent Ost and Keith Schultz voting aye, no other discussion motion carried. Treasurer continued to prepare checks for Board to review, approve and sign.

Board and RBS discussed road conditions throughout township, removing of unnecessary brush in ditches, trimming trees along roads, and necessary cracking that needs to be completed on Schuelke Bh. Rd. and Spring Lk. Rd.; all of these projects will be implemented as soon as weather allows. Road restrictions were put on roads on March 09, 2020.

Brent will contact contractor about removal of chimney and necessary repairs completed before spring rains start.

All reviewed dates of upcoming meetings during March/April and discussed who will be able to attend so Treasurer will prepare checks for attending. Treasurer had all checks prepared for Board to review and approve. Motion was made and second with Dale Diedrich, Brent Ost and Keith Schuktz voting aye to approve and pay checks #969 to #987, voided out #'s 986, 988 and 989, no other discussion motion carried.

There was no other township business needing to be addressed motion was made and second to adjourn with Dale Diedrich, Brent Ost, and Keith Schultz voting aye, motion carried. 7:40 pm.
