Treasurer continued to prepare checks for Board to review approve and sign.

A resident living @ 3140 Little Ida Bh. Rd representing several residents asked if sign could be posted for that area of road stating "NO OUTLET". Board discussed other township roads that are in need of new signs, Dale will order signs that are needed and road maintenance will get them installed. Shea Rd going north is in need of repair and Limb Rd repairs were also discussed, Keith had talked to Brandon supervisor regarding this situation, he will keep Board informed as progress is made. Chloride application was discussed for township roads.

There were several building permits reviewed, elections in August discussed-training will be completed on line for all judges and Treasurer had all claims prepared and ready for Board to review, approve and sign. Claims #1003 to #1020, voided out # 1005, totaled \$28,210.99. General Fund \$6,503.67, Road/Bridge Fund \$20,656.73, Fire Fund \$288.87, Park Fund \$667.24 and First Responder Fund \$94.48; motion was made and second to accept and pay all claims with Dale Diedrich, Brent Ost and Keith Schultz voting aye. No other discussion motion carried.
