TREASURER gave the prepared financial report since the September 10, 2020 meeting. Income for the township totaled \$12,648.22. Balance on 10/01/2020 in the General, Road/Bridge and Fire Funds totaled \$668,780.95; Park Fund \$3,785.03, Fire Truck Fund \$16,947.00, Hall Maintenance \$57,861.13 and First Responder \$2,936.66; balance in checking on 10/01/2020 was \$1,329.23; and Treasurer transferred \$20,000.00 from savings to checking in September. Motion was made and second to accept the report as prepared and read with Dale Diedrich, Brent Ost and Keith Schultz voting aye, no other discussion motion carried. Treasurer continued to prepare checks for Supervisors to review.

There was a short discussion regarding installation of a flag pole with lights at the hall. There were several questions left unanswered so a decision was tabled till a future meeting when more information is obtained it was also decided it will be addressed at the Annual Meeting where voters can discuss and decide if it will be completed.

Supervisors and Road Engineer discussed road projects completed and those that will be completed in spring of 2021, mowing of ditches, tree trimming, gravel that needs to be removed out of creek on Mum's Rd, trees in ditch along Vermont Lk. Rd., and a larger culvert on Thoennes Ln. That project will be completed when Board and RBS get all details in order and inform residents in that area of details.

Snow plowing for hall will be completed by individual that is also doing removal at L.V. Merc., Brad Swenson.

## ROAD MAINTENANCE AGREEMENT with BRANDON TOWNSHIP

Ida Township had sent copy of finale invoice for the tarring of Big Horn Bay Rd project. LV Township's 20% share with assessments was \$23,586.37. Clerk will send letters to residents of Leaf Valley that are living within this project. Motion was made and second to pay to Ida Township the complete payment with Dale Diedrich, Brent Ost and Keith Schultz voting aye, no other discussion motion carried.

Board reviewed and discussed the propane agreement with HiWay Amoco. Motion was made and second to contract with them 2,500 gallons @ \$1.09 with Dale Diedrich, Brent Ost and Keith Schultz voting aye, no other discussion motion carried.

At this time Board reviewed building permits. Motion was made and second to accept and pay checks #1092 to #1108 totaling \$39,967.26, General Fund \$2,513.36, Road/Bridge Fund \$32,811.07, Fire Fund \$1,513.02, Park Fund \$987.28 and Hall Maintenance \$2,142.53 with Dale Diedrich, Brent Ost and Keith Schultz voting aye. Motion carried.

There was no other Township business needing to be addressed motion was made to adjourn with Dale Diedrich, Brent Ost and Keith Schultz voting aye, motion carried. 8:10 pm
