Board and Richard discussed condition of few of gravel roads that need blading and projects that will be started as soon as possible in spring, all in all roads, gravel and tarred, are in good condition for start of winter season. Board, Richard and Gary discussed many gravel trucks traveling on roads that are considerably overweight all the time and why nothing is done. All agreed an on-going situation that is county wide until county stops this nothing township can do.

Fire contracts for 2021 were signed and clerk will send to Effington and Ida townships, there were no changes. CARES Grant paperwork was completed and filled out Clerk and Treasurer will review all invoices and split into FD and FRD funds. This grant money had to be used for added expenses in these departments all due to coronavirus.

General election was very successful. The township had over 92% of township casting votes. No problems all went smoothly and had awesome election judges that hopefully will continue to assist with future elections in township. HUGE THANK YOU to everyone for voting and being judges.

At this time Board reviewed all mail, reviewed building permits and Treasurer had checks #1109 to #1129 prepared for Board to review, approve and sign. Motion was made and second to accept and pay all invoices with Dale Diedrich, Brent Ost and Keith Schultz voting aye, no other discussion motion carried. Funds totaled \$18,983.50; General Fund \$6,478.74, Road/Bridge Fund \$6,387.75, Fire Fund \$4,463.51, Park Fund \$1,354.54 and First Responders Fund \$298.96.

There was no other township business needing to be addressed motion was made and second to adjourn with Dale Diedrich, Brent Ost and Keith Schultz voting aye, motion carried. 8:00 pm
