Don Kalpin shared with the Board the up to date information fire department discussed regarding the purchasing of new fire truck replacing the old grass fire rig. Because the financing options continually change it was agreed at the next monthly fire department meeting all options will be considered and discussed and this information will be brought to Township Board. Motion was made and second with Dale, Brent, and Bob voting aye for a new grass rig fire truck to be purchased replacing the DNR grass rig pickup. Returning to the DNR or selling it will be decided at future meeting, motion carried.

Board and RBS discussed the culvert installation on Reidel Bh. Rd. and Ruckheim Rd that both projects will be started soon before weather conditions change. There is a boat lift in right away at the Lucky Acres Campground a letter to owner will be sent and Dale agreed to visit with owner of camp ground explaining situation. The tarring project on Little Ida Bh. Rd. NW has not been completed but contractor has until October 31, 2022 for this to be completed, some driveways have had changes or repairs completed already and the turn-around has also

been finished. Once contractor starts it will take a very short period of time to finish. At this time motion was made and second to accept:
