CHAIR, Dale Diedrich called the March 09, 2023 township monthly meeting to order @ 7:00 pm with Pledge of Allegiance. Supervisors Brent Ost and Bob Hansen, Treasurer Barb Guenther, Don Kalpin representing fire dept., Road Engineer Richard Vogt, and Matt Tikkanen of the Assessor's office were also present.

CLERK, read minutes of the February 09, 2023 monthly meeting. A correction made that the cost of the Little Ida Beach tarring project should be \$288,167.28, not \$273,758.92. Motion was made and second to accept minutes with correction with Dale, Brent, and Bob voting aye, no other discussion motion carried.

TREASURER gave the prepared monthly financial statement. On 03/01/2023 there was \$427,232.67; in General, Road/Bridge and Fire Funds, FR Fund \$7,772.58, Park Fund \$1,426.46, H. Maintenance Fund \$50,585.84 and in Covid Fund \$49,447.89. Checking account balance was \$3,668.26 and there was income of \$301,607.41; Treasurer transferred \$263,000.00 from savings to checking. Motion was made and second with Dale, Brent, and Bob voting aye to accept the report as prepared and given, no other discussion motion carried.

Don Kalpin informed Board the new pickup, grass-rig, has been ordered with an increase of price of \$2,500.00 to \$2,800.00. He will keep Board up to date when status of order changes.

Road Engineer and Board discussed condition of few gravel roads and agreed in spring couple of these roads will need extra gravel considering weather conditions.
