Chair, Dale Diedrich called the Aug 8th, 2024 scheduled township monthly meeting to order at 7:00pm with the Pledge of Allegiance. Members of Board present were Brent, Trista, Barb, Issy and Pam. Supervisor Bob not present for meeting, out of town. Richard Vogt and 2 residents from Little Ida Beach Rd were also present.

Minutes: A motion was made and second to accept the July 11th, 2024 minutes with Dale and Brent voting aye, no other discussion, motion carried.

Treasurer gave the monthly financial report. Interest earned at Bremer for month \$1,141.73, checking account balance \$7,819.82, balance in General, Rd/Bridge and Fire Funds \$659,520.53, FR Fund \$7,826.50, Park Fund \$1,471.45 and Hall Maint \$36,263.87. Treasurer transferred \$62,000 from checking to savings and there was income into township totaling \$6,915.11. Motion was made and second to accept this report as prepared and read with Dale and Brent aye, motion carried. Treasure continued to prepare checks for Board.

Visitors: Visitors from Little Ida Beach Rd present to wondering if we had more information when the seal coating would be completed. Dale stated that it needs to be completed by Sept 15th, 2024. We have not been informed of a start date. Clerk, Trista stated residents of Little Ida Beach Rd will all be receiving a letter, drawn up by our attorney to inform them that the seal coating project was approved by the board, cost, and dates of completion.

RBS completed the culvert replacement on Thoennes lane. Dale stated that RBS needs to address Dittberners Crk Rd and get some gravel hauled in.

No members of Fire Dept or First Responders present at meeting.

Dale contacted Soil and Water re: Reidel Beach Road washouts. Soil and Water stated they would come up with a plan of their own and present it to the land owners on Reidel Beach Rd. Dale also contacted Johnathan Thoennes about widening the ditch, narrowing the road, and rip rapping around the culvert to help them from washing out and plugging up.

Dale stated that he has been contacted about weed growth in Leaf Valley Township again. Dale stated that Tom Anderson at Public Works will contact residents about weeds. Leaf Valley Township will not be sending notices out again.

There was no other township business needing to be addressed motion was made and second to adjourn with Dale and Brent voting aye, motion carried. 8:10pm
