**Chair,** Dale Diedrich called the November 14<sup>th</sup>, 2024 scheduled township monthly meeting to order at 7:00pm with the Pledge of Allegiance. Members of Board present were Brent, Trista, Barb, Issy and Pam. Richard Vogt and Joel Wussow were also present. Bob was not present due to medical reasons.

**Minutes:** A motion was made and second to accept the October 10<sup>th</sup>, 2024 minutes with Dale and Brent voting aye, no other discussion, motion carried.

**Treasurer** gave the monthly financial report. Interest earned at Bremer for month \$914.28, checking account balance \$76,423.60, balance in General, Rd/Bridge and Fire Funds \$460,717.69, FR Fund \$6,660.63, Park Fund \$601.24 and Hall Maint \$36,263.87. Treasurer transferred \$111,000.00 from savings to checking and there was income into township totaling \$61,899.39. Motion was made and second to accept this report as prepared and read with Dale and Brent voting aye, motion carried. Treasure continued to prepare checks for Board.

**Visitors:** Joel Wussow present to discuss Hidden Valley Rd Taring Assessment. Dale explained that it was based off of the number of parcels on Hidden Valley Rd and that he has 2 parcels and is responsible for 2 parcels. Joel also was not pleased with how his driveway was left. He felt it should have been more tapered down into the driveway like others on the rd. Dale explained that other residents on the road paid for more tar to be placed on their driveways. Dale also reminded Joel with winter months upon us to not be pushing snow across the roadways as it is illegal.

Richard Vogt present from RBS. Stated that roads are looking good at this time. Dale informed Richard that once discussed and approved they will need to get started on the turnaround on Buck Ridge Road. Dale would like RBS to have this project completed yet this year.

No First Responders or Fire Dept members present at meeting. Dale talked with Donny Kalpin to see if there was any new business with Fire Dept. Donny stated that they were looking into some used and refurbished extrication equipment.

Buck Ridge Road turnaround discussed. Dale met with Radach Land Surveying and the land owners on Buck Ridge Rd to determine the best location for turnaround. It was determined that the best placement for the turn around would be at the corner beyond Dean Stangler's driveway. A motion was made and second to approve the turnaround on Buck Ridge Road at the corner after Dean's driveway with Dale and Brent voting aye, motion carried.
