WHEREAS: MN Statutes Section 203B.121, subd.1 requires the Town Board, as the governing body of the town, to appoint a ballot board to process all absentee ballots returned to the town clerk for the election scheduled to be held on Tuesday, March 11, 2025.

WHEREAS: The ballot board must consist of election judges trained in the handling of absentee ballots, or staff trained as election judges; and

WHEREAS: Even though only two members are required to meet whenever an absentee ballot needs to be processed, the ballot board must consist of at least the same number of members as the minimum number of required election judges for the township election, which pursuant to MN Statues Section 204B.22 has been determined to be three () for the March 2025 election for the Leaf Valley Township; and

Whereas, the Town Board for the Town of Leaf Valley has appointed its election judges for the March 11, 2025 election as required by Minnesota Statues Section 204.2121;

Now Therefore Let It Be Resolved: That the Town Board for the Town of Leaf Valley hereby appoints the following election judges to serve as the ballot board required to perform all duties required in the processing of absentee ballots required under Minnesota Statues Section 203.121 and all other applicable statues and rules:
