Chair, Dale Diedrich called the September 10, 2026 scheduled township monthly meeting to order at 7:00pm with the Pledge of Allegiance. Supervisors Brent Ost and Bob Hansen, Treasurer Issy Swenson and Clerk present at meeting. One other guest in attendance.

Minutes: A motion was made and second to accept the Aug 13, 2026 minutes with Dale, Brent and Bob voting aye, no discussion, motion carried.

Clerk gave the financial report/statement for August 31, 2026. Interest earned at Old National Bank for month \$734.43. Checking account balance \$36,803.11. Balance in General, Rd/Bridge and Fire Funds \$638,170.12, FR Fund \$8,064.69, Park Fund \$2,692.11, Hall Maint \$23,853.58. Treasurer transferred \$60,000.00 from savings to checking. There was income into township totaling \$13,160.70. Motion was made and second to accept this report as prepared and read with Dale, Brent and Bob voting aye, motion carried.

No Road Engineer present.

No one present from First Responders or Fire Dept.

Guest in attendance was William Moeller Jr representing his mother who lives on Krohnfeldt Beach Rd NW. They have concerns with the position of the road and that it is not in the correct area. They are wondering if it could be moved over and widened according to the original plat layout. Board explained they have attempted this in the past but had issues with running into the sewer line. Board heard out the concern and will discuss with our Road Engineer to see if there is anything we can do to address this concern.

In new business, Board discussed the delay in the sale of the old First Responder Truck. There have been some issues obtaining the title to complete the sale. Board hopes to have issue resolved soon and the sale to be completed by November meeting.

In old business board discussed the transfer back of monies from Road and Bridge back into the General fund, that was transferred back in 10/2024 to cover road projects on Little Ida Beach Rd and Hidden Valley Rd. A motion was made and second to transfer \$50,000.00 from Road and Bridge back into the General Fund with Dale, Brent and Bob voting aye, motion carried.

At this time Board reviewed Licensing, Building permits and all other township correspondence.

There was no other township business needing to be addressed motion was made and second to adjourn with Dale, Brent, and Bob voting aye, motion carried. 7:48pm.
