## Eligibility

Entries must have been completed within the last five years and must not have hung in any previous Morristown Art Association juried show. All works must be the original work of the entering artist. Giclée prints, copies of materials, and published photographs are not considered originals. Artwork copied from published materials is not considered original.

## Entries

- Three (3) entries may be submitted
- Types of work: Oil, Acrylic, Watercolor, Drawings, Graphics, Pastels, Mixed Media, Collage, and Sculpture and other threedimensional work regardless of media
- Photography will not be accepted
- Size: No larger than 48 inches on any side, including frame. Weight must not exceed 30 lbs.
- All two-dimensional works must be appropriately framed, dry and ready for hanging upon submission
- Screw eyes should be placed within the top 1/4 of the height of the frame to avoid tipping forward while hanging
- Keep wire relatively taut so that hanging mechanism remains hidden behind frame
- Gallery wrap is acceptable if sides are painted and no staples are visible
- Pieces requiring special installation or unusual hanging techniques are not acceptable. If a piece is not stable or falls, it will be removed from the show.
- Groupings not permanently attached to each other are considered separate pieces
- Works must be allowed to hang for the duration of the show and picked up on the date indicated

- Over \$1,000 in total cash to be awarded

## **Entry Fee**

- Only checks or cash accepted
- MAA Members in Good Standing \$20 per piece
- Non-members \$25 per piece

A 20 percent commission will be charged for all sales of artwork during the show with 10 percent going to the Morristown Art Association and 10 percent to Rose Center. Purchases are made through Rose Center. Please price your work accordingly. The artist receives 100% of listed price for patron Purchase Awards.
