



**Innova Riding Stables Release and Hold Harmless Agreement**

The Undersigned acknowledges the inherent risks involved in riding and working around horses, which risks include bodily injury from using, riding and being in close proximity to horses among other risks, and further that both horse and rider can be injured in normal use or in competition and schooling.

I have personally had the opportunity to review the premises of Innova Riding Stables, LLC operated by Roxanne Khan, located at 2375 New Hanover Square Road, Gilbertsville, PA 19525 and have satisfied myself as to the condition of the premises and the design, structure and circumstances involved with the areas I would like to use. I acknowledge that I have no necessity to participate in this activity and that there are other facilities at other sites that I can use.

In consideration for the privilege of riding and working around horses and/or being a spectator at the activities being held at the above described property and participating in this activity, the undersigned does hereby agree to hold harmless and indemnify the owners and occupants of said property and further release them from any liability or responsibility for accident, damage, injury or illness to the undersigned or any horse owned by me or to any family member or spectator accompanying the undersigned on said premises. A parent must sign and agree to hold harmless the owners or occupants of Innova Riding Stables, LLC on behalf of their child. I fully understand that lessons, schooling, cross-country horseback riding, horse shows, and trail riding are very dangerous activities. I fully understand the risks of equestrian activities include but are not limited to: (1) the propensity of an equine to behave in a dangerous ways which may result in injury to the rider, trainer, groom, handler or spectators, (2) the inability to predict an equine's reaction to sound, movement, objects, persons or animals, and (3) hazards of surface and subsurface conditions and riding over unknown terrain where hazards may be hidden by vegetation and development. I or my child wish to participate in these activities knowing that they are dangerous. I accept and assume all risks of injury (including death) to my property or myself as stated in Pennsylvania equine law for myself or my child.

In exchange for being permitted to participate in these activities, I do for myself, my heirs, guardian and legal representatives, release and agree not to make or bring any claim of any kind against the owners or occupants of the above described property, Rukhsaan Khan, her employees, volunteers, or any other representatives, or any horse owners on the property whose horse I or my child may ride or come in contact with, for any injury (including death), to me or my child or any damage to my property whether from anyone's negligence or not, or any other cause, arising out of my presence on the premises or my or my child's participation in these dangerous horse-related activities. I also agree that if anyone makes any claims because of any injury to me or my child (including death), or for any damage to my property, I will keep all of those released by this agreement free of any damages or costs because of those claims. My signature hereby indicates my agreement for myself or my child to wear a riding helmet at all times while riding on the premises and I and my child shall obey all rules of the property owner and barn manager. If siblings/guests of riders are present they are the responsibility of the parent/guardian and must be supervised at all times. Innova Riding Stables, LLC takes no responsibility of accident or injury to siblings/guests.
