Sealed bids for the new roof located 279 E. Main Street, Hazard, KY 41701 will be received by Ellen Vance, Chief Executive Officer, at the Administrative Office of the Little Flower Clinic, located at 279 E. Main Street, Hazard, KY 41701, until two o'clock (2:00 p.m.) EST on Monday, September 22, 2025, and then publicly opened and read aloud at 3:00 p.m. EST.

A Non-Mandatory Pre-Bid meeting shall be held at the job-site on Friday, September 5, 2025 at two o'clock (2:00 p.m.) EST, located at 279 E. Main Street, Hazard, KY 41701.

The project consists of the re-roofing all sections of The Little Flowers Clinic— cost of all permits, decking repairs, and labor and materials should be included in your bid:

1. Preparation and Planning:

Site Assessment: Before re-roofing, the building's structure and materials should be assessed to determine the best approach and identify potential hazards.

Permits and Safety: This construction requires permits and adherence to safety regulations to protect workers and the surrounding environment.

2. Re roofing Process:

All job specific specifications, job specific details, along with scope of work will be provided at pre-bid along with verifying existing decking on all sections.

3. Debris Management:

Re-Roofing debris should be properly disposed of in the landfill.

Salvaging and Recycling: Materials with salvage value, like steel, copper, aluminum, and some types of wood, will be given to the approved bidder to be taken to scrap yards or recycled for reuse, if they so choose.

4. Site Preparation for Future Use:

Clearing and Grading: After job site completions, the site is to be cleared of all equipment and debris resulting from the project.

KMHA reserves the right to waive any informalities or to reject any or all bids!

KMHA may cancel an Information for Bidders (IFB) or reject all bids if it is determined that such decision is in the best interest of KMHA. Bidders will be notified in writing of such cancellation or rejection. KMHA may allow a vendor to withdraw their bid if requested at any time prior to the bid opening. Late bids will not be accepted.
