**GLPA membership meeting Monday, June 16 at 7 pm at the
Warren County Municipal Center room 5-110**

2025 Aquatic Plant Management and water use restrictions: 35 acres will be treated with herbicides to control milfoil and nuisance pondweed on June 10, weather permitting. See the area treatment map at our website www.glenlakeny.org for specific locations. Water use restrictions include: No swimming the day of the treatment. No domestic water uses until concentrations reach <50ppb. No irrigation, including lawns and flowers, in areas treated with the Clearcast herbicide (see area treatment map). It takes approximately 3 weeks to obtain the water testing results. There are no restrictions for fishing. Go to our website for any updates.

June 16 meeting discussions: (1) an auto collision repair center is proposed to be constructed at the corner of Glen Lake Rd and Route 9 [Olde Post Grille location], which may pose some threats to the lake, (2) the Glen Lake Watershed Management Plan, (3) review of septic system information, E. Coli water sampling, and septic grants.

Your membership to the GLPA is your voice in lake matters. Your membership enables the Association to act as an advocate for the health and wellbeing of our beautiful lake and the Glen Lake community. Please find attached the 2025 membership application. Sediment discharge into Glen Lake: On May 16 a large beaver dam broke open on a pond near Goggins Rd (Gurney Lane). This resulted in the flooding of Route 9 north of Route 149. The flood waters emptied into Rocky Brook, an inlet tributary into the Glen Lake Fen, which resulted in substantial amounts of sediment into Glen Lake. A large, brown plume could be seen in the lake for a few days. The water has since cleared, but this event may have contributed to nutrient loading from the runoff.

Don't forget that as of this year ALL motorized boat and personal watercraft operators are required to have a **NYS Boater's Safety Certificate** carried with them.

Lake Etiquette Reminders: (1) Please don't feed the waterfowl – ducks, geese, etc.; it's bad for them and bad for our lake. (2) Please stay outside of the buoyed areas at the inlet, in St. Mary's Bay, and off Windmill Point. The buoys are there because invasive and nuisance aquatic plants are present and invasives spread by fragmentation caused by boating activities in those areas. (3) Remember that sound travels unimpeded over water; please be mindful of your volume and activities on the water. (4) Please inform your renters of boating rules and lake etiquette.
