This is an informational, not a regulatory survey, that will help us complete our Glen Lake Watershed Management Plan. If you have questions about the survey, this meeting will be your opportunity to speak directly with Chris Round of LaBella Associates about the use of the survey and how it will help our GLPA Watershed Management Plan.
