We only need to have one survey done for each septic tank on your property. Of all the surveys returned we will place the names of the returners in a basket and two winners will be randomly chosen for a \$100 gift certificate to the Docksider and a \$75 gift certificate to the Docksider. MANAGEMENT of INVASIVE AQUATICS 2022 - Because we were unable to manage the lake last summer, we observed a significant increase in invasive aquatic vegetation. As a result, we will be slightly increasing the number of acres treated this season to a maximum of 34. In early June, Aquathol Super K will be applied to control the spread of Eurasian Milfoil, Curlyleaf Pondweed, and Brittle Naiad. The date of the application and any water use restrictions will be posted to the GLPA website as soon as available. We will also be doing four weeks of diver assisted hand harvesting to clean up any remaining areas later in the season. Any questions contact Paul Derby @ 518-761-7015.
