SAFE BOATING - Safe boating involves knowing the rules of navigation. Please go to the New York State Rules of Navigation web site and familiarize yourself with the rules. Many of the rules involve distance - distance from other boats and most importantly distance from shore. You should stay 100 ft. from shore or a dock if you are going faster than 5 mph. Courtesy

requires that the faster you are going or the larger the wake you are making then you should stay farther from shore. Navigation lights must be displayed between sunset and sunrise . Canoes or kayaks on the lake after sunset should have a flashlight and display it soon enough to avoid a collision. Thank you !
