RELEASE & AUTHORIZATION FORM
PLEASE READ CAREFULLY

Welcome to Eclipse Dance Complex! We are so excited to have you with us. Below is some important information regarding our studio. Please read carefully and sign BEFORE attending any classes. If you have any questions or concerns, do not hesitate to contact us.

At Eclipse Dance Complex, our number one priority is the safety of our students. We pride ourselves on maintaining a healthy, safe, and happy environment for your child(ren).

Eclipse Dance Complex generally follows the calendar of Sayville School District. Emergency closings due to weather, etc. will be announced thereafter the decisions of SSD. Please download the Band App to be sure you are updated on any last minute closings or schedule changes. There are three (3) emergency closings built into your season tuition. Any additional closings will be discussed further.

NO REFUNDS ON TUITION WILL BE GIVEN. If you have to miss a class due to illness, vacation, etc. it is the responsibility of the student to schedule makeup classes. See the front desk to schedule these makeup classes, whether they be private lessons or other group classes.

CLASS/REHEARSAL INFORMATION

Dancerâ€™s will receive a full curriculum based on the staffâ€™s discretion. Each class will include a warm-up and stretch session, followed by practice of learning technique, practicing choreography, etc. Eclipse Dance Complex/Dance Net Studios LLC has the right of class placement based on level.

DANCER RESPONSIBILITY

It is the dancerâ€™s full responsibility to come to class prepared in proper attire, water (or an athletic beverage), correct shoes, and anything else needed for their classes. If a dancer comes to class unprepared once, they will receive a warning. If it continues, the dancer may be asked to leave class and a parent/teacher meeting will be requested. We understand that sometimes students will forget things occasionally and parents have several other responsibilities and priorities at home. Our studio is willing to make light accommodations for you and your family to make your studio experience as easy as possible. Please see the front desk for more information.

PARENT RESPONSIBILITY

We ask that all parents with studentâ€™s younger than the 1st grade remain in the lobby during class time. We are happy to offer free wifi to all parents for anytime they need it. Make yourself at home in our lobby! Most importantly, please make sure you are frequently checking your

emails and keeping in touch with the front desk for updates. We are also on the Band App, where you can find all studio information and message our staff and anytime. If you have any questions about the studio, please do not hesitate to ask.

PICTURE DAY

One of the great things we offer at our studio is picture day. Each class will have its own time slot during the week of pictures. We hire a separate company and maintain an organized schedule, so it is very important that we stick to the schedule that is provided. Although individual photos are not required, we highly encourage all students to participate in each class's group photo.

DRESS REHEARSALS

All classes will have 2 dress rehearsals; one in-studio and one on stage. These dress rehearsals are mandatory and all dancers MUST attend to perform in the end of year recital. We will post the dates for these dress rehearsals before December holiday break, and we will have the schedules released after February Break.

END OF YEAR RECITAL

This is the moment we have all been waiting for! Our students have all worked so hard for these moments on stage, and we are always so excited to have friends and family join us for the show. As we get closer to the end of the year, we will release specific recital packets with lots more information, including dates, the venue, stage orders, etc.

ASSUMPTION OF RISK

Dancing is a physical activity that involves, but are not limited to, jumping, kicking, rotation, and coordinated body movements. By signing this waiver, you agree that your child's participation involves inherent physical risks and agree to assume the full risk of any bodily injuries (including death), damages, or loss which you / your child may sustain as a result of any activities arising out of, connected with, or in any way associated with you / your child's participation in such activities. You certify that you / your child's present level of physical condition is consistent with the demands of active participation in dance. You agree that you, your heirs, next of kin, executors, administrators and assigns do hereby fully release Eclipse Dance Complex/Dance Net Studios LLC from any and all liability, claims and causes of action arising from any injury, damage or loss you / your child may sustain as a result of your / their participation in such activities and covenant not to sue Eclipse Dance Complex/Dance Net Studios LLC for the same, whether caused by the negligence of Eclipse Dance Complex/Dance Net Studios LLC or otherwise. This is a complete and irrevocable release and waiver.

MEDICAL INFORMATION AND AUTHORIZATION

You have disclosed all illnesses and conditions affecting my child to Eclipse Dance Complex/Dance Net Studios LLC. In the case that my child sustains an injury or medical emergency during activities relating to Eclipse Dance Complex/Dance Net Studios LLC and in the event that your child or yourself cannot respond at the time of the emergency, I hereby

authorize the staff at Eclipse Dance Complex/Dance Net Studios LLC to seek, administer or have administered whatever first aid or emergency medical care is deemed necessary for your child's welfare. This authorization DOES NOT require a prior determination of a threat to your child's life or of serious permanent injury. You will take full financial responsibility for any medical treatment. You have custody of my child and the right to make decisions for him/her.

MODEL RELEASE AND AUTHORITY TO IDENTIFY

You acknowledge that your child or yourself may be photographed or recorded for marketing or public relations purposes. You hereby grant Eclipse Dance Complex/Dance Net Studios LLC permission to use photographs of your child or yourself as elements of a photographic piece or to put the photographs to any legitimate uses they may deem proper.
