 - Furniture will be done last following landscape touchups

Potential future common area projects:

- Pathway lighting replacement quote obtained:
 - Planning for higher lights spaced further apart to avoid mower damage
 - Bid for replacement is \$7k
 - Will wait until pool is complete to understand funds remaining
- Tennis court repaint
 - Board will obtain bids (previously quoted at \$12K)Homeowner has offered to paint it
- Tennis court light conversion
 - Brief discussion of solar lighting

Owner Discussions:

- Ryan and Andrea Howard: Concerns about unprofessional behavior from tree trimmers. Frank T. assured homeowners he has and will address with tree trimming management – unprofessional conduct will not be tolerated. Dan S. informed Ryan and Andrea that the insurance company holding the policy for the MVGLTA common areas will not insure playground equipment in the common areas. Homeowners agreed to remove swing set and hammock from common areas to avoid insurance issues. Homeowners expressed enthusiasm for tree replacement and offered sourcing suggestions.
- David Stout: Concern with condition and appearance of courts (Tennis and Pickleball) and surrounding benches. Board communicated that potential improvement project will be considered following completion of the pool project.
