Program Name: COSMETOLOGY

Language of the Program: ENGLISH

<u>Objectives of the Program:</u> The Cosmetology course is designed to provide the necessary practical skills and theoretical knowledge to obtain licensure from the South Carolina State Board of Cosmetology. Upon completion of the program requirements, the graduate will be:

- Prepared to pass the Theory and Practical South Carolina State Board of Cosmetology Licensure Exams.
- Able to perform skills in areas of hair cutting, hair styling, hair coloring, skin care, make-up
 application, manicuring and pedicuring.
- Able to perform entry level skills in the cosmetology industry.
- Able to apply business skills communication and develop business skills and knowledge.
- Able to analyze client hair, skin, or nail issues and provide a solution through use of problem solving skills learned.
- Able to project professionalism.

<u>Description of Cosmetology Program:</u> The COSMETOLOGY PROGRAM at Regina Benton School of Cosmetology consists of instructional material relevant to the Cosmetology Industry. Successful completion will prepare the program student with the skills necessary to pass and procure licensure from the South Carolina State Board of Cosmetology and employment within the Cosmetology Industry.

The Cosmetology Program is a Clock-Hour Based Program. The Program consists of 1500 Clock Hours of instruction as required by the SC State Board of Cosmetology. Those hours are divided between Theoretical and Practical instruction.

The Theoretical portion consists of instruction in Anatomy, Biology, Physiology, Chemistry, Electricity, Safety and Infection Control. You will learn various aspects of the human body relevant to the Cosmetology Industry. These include Skin, Hair, Scalp, Nails, etc. Along with this, you will learn business related skills such as; business training, business building, professionalism, resume writing, and job interviewing skills.

The Cosmetology Program is comprised of two levels of Classes of training. They are:

- Foundations Class
- Performance Class

Foundations Class

When a new student begins their Cosmetology Education, they will begin in the Foundations Class. They will be in this Foundations Class for 360 Hours learning all of the pertinent skills and knowledge that will allow them to progress to the Performance Level. In the Foundations Class they will learn all of the basic skills utilizing mannequins as the instructional model to develop skills necessary to perform practicals on live human clients. As they progress in

the Foundations Class, the student will be allowed to schedule family and friends for practical services that the student has learned and developed adequate skills in during their Foundations progression.

Topics covered during the Foundations Class are:

The requirements for a student to progress to the Performance Class are successfully complete all required practical skill requirements, including rubrics and theory exams of the Foundations Class. All Theory and Practical evaluations must be passed with a cumulative grade of 80%. Once the student has successfully completed these requirements and have achieved 360 Clocked Hours of instruction, they will progress to the Performance Class.

During the Foundations Class (0-360 Clocked Hours), Students will complete the following assigned requirements:

-11 Chapter Tests -Week 1-11 -Rubrics

-Week 12 – Final Rubric -Chapter Work

-Procedure Cards -Practical Requirements

Performance Class

After completion of the Foundations Class, the Student will progress to the Performance Class. Here they will complete the remaining 1,140 Clocked Hours of their Cosmetology Program. They will continuously enhance their cosmetology skills and gain additional knowledge and skills towards their ultimate graduation.

The Performance Class may be divided up into several sub-classes due to Student-Instructor ratio as prescribed by SC State Board Regulations. When the school exceeds 20 students per instructor, we will implement a class rotation scheduling. For example the Performance Class will be divided up into two groups consisting of less than 20 students per instructor. One class will be out on the Performance Floor, while the other will be in the Classroom. They will alternate between the classroom and Performance Floor to enhance their skills.

During the Performance Class (360-1500 Clocked Hours), Students will complete the following assigned requirements:

-450 Clocked Hour Exam -900 Clocked Hour Exam and Rubrics

-1200 Hour Exam and Rubrics -1500 Hour Final Exam -3 State Board Licensure Exams with -23 Chapter Exams

80% or Higher Grade

-Any other assignments required by Instructor for class purposes

Grading

All Theory and Practical Evaluations must be passed with a minimum accumulative grade of 80% in areas of instruction. The Evaluations are weekly Theory Exams and Rubrics with an accumulative grade of 80%.

Student Evaluation

Students are evaluated throughout their cosmetology program. Along with the written exams and practical exercises required throughout the program, students will receive a Satisfactory Academic Progress (SAP) Evaluation at three clocked hour milestones. When they reach 450, 900, and 1200 clocked hours, they will be evaluated on their attendance accumulated percentage (minimum 70%) and academic accumulated grade (minimum 80%).

Curriculum Instructional Techniques

The Cosmetology Program is taught using numerous instructional techniques which include, but not limited to combinations of lectures, demonstrations, visual aids, printed illustrations, guest presentations, external classes (hair shows, salon visits, etc.), cooperative learning, online training videos, hands-on instruction, with written and practical evaluations.

Graduation Requirements (as outlined in the Student Catalog):

- -Completion of State Board required 1500 Hours of instruction; and
- -Fulfill all practical graduation requirements of the school and State Board; and
- -Pass all three State Board Licensure Exams with an 80% accumulative grade; and
- -Complied with all school policies; and
- -Completed all required exams and course requirements; and
- -Satisfied financial obligations requirements up to graduation date; and
- -Made arrangements to pay all tuition, fees, and overtime charges (if applicable); and
- -Returned any, and all, Regina Benton School of Cosmetology property (if applicable, and
- -Pay all outstanding fees owed from Student Services, extra supplies, etc. must be paid prior to Receiving your Cosmetology Diploma

Maximum Time to Complete Program

Maximum time to complete the Cosmetology is calculated using 150% of the program required hours (1500 Clocked Hours). The equates to an overall attendance greater than 67%. This is not to be confused with the required Satisfactory Academic Progress (SAP) Evaluations period requirements of 70% attendance.

Distance Education

Regina Benton School of Cosmetology doesn't offer a Distance Education (DE), or Virtual Education in its normal curriculum. We have had to utilize Distance Education on very limited basis (i.e. Covid-19 Pandemic related issues) in the past as authorized by state agencies and the accrediting agency (NACCAS). Therefore, Distance Education will only be utilized as a means of instruction in rare instances such as previously mentioned.
