Company Ownership: Pineview Pet Boarding, LLC is a Mississippi Limited Liability Company based in Jones County, privately owned and operated by its principal operators (Tori and Jeremy Parker).

Pricing:

Boarding: \$30/night

The second dog sharing the same kennel (from the same family) is \$25/night. Third dog \$20/night

For example: if you are dropping off 3 dogs and 2 of them are staying in the same kennel, while the other one is staying alone the total for one night would be \$85. If all three dogs shared the same kennel, the price would be \$75 per night.

Medication administration is included in the price.

We encourage you to bring your own dog food, but in case you forget there are two options:

Dry kibble \$2/day Farmer's dog (or something similar)\$5/day

Bathing (Not available yet)

*must specify **24 hours prior** to pick up whether the pet would like a bath.

Small Dog (less than 20 pounds):	\$15
Medium dog (20-50 pounds):	\$20
Large dog (51-90 pounds):	\$25
X-Large dog (91+ pounds):	\$30

Hours for Drop Off and Pick-up are pre-arranged times discussed with clients. These can vary. These can be any time During summer (when school is out). Hours will be revised once school starts back (August 1st). Appointments will be made for check-in/check-out times; however, must be approved by the boarding staff. The owner determines hours of operation and can change at any time without notice.

***Dogs must be current on vaccinations (Bordetella, Rabies, Distemper) *must be current on flea, tick, and heartworm preventative.**

Payments must be made at the time of picking up. Acceptable forms of payment include cash, check, venmo, and paypal.

Any medical expenses will be my responsibility and I release Pineview Pet Boarding, LLC of any charges.

____ 3. Pineview Pet Boarding, LLC reserves the right to not accept a dog into the facility for any reason. Liability coverage for Pit Bull breeds is not accepted and coverage for allowing as such breed in the facility is the sole responsibility of the owners. All rules of the facility are subject to change at the sole discretion of Pineview Pet Boarding, LLC.

____ 4. Pet owners represent and warrant that a) the dog is free of any infectious disease; b) the dog is current on all vaccinations, including DHPP, Bordetella, and Rabies; c) the dog is free from parasitic problems, internal or external (including fleas and ticks), and is free from any contagious skin disorders. **Dogs with flea or tick problems will be treated at the owner's expense.**

_____5. All charges must be paid in full upon pick-up of your dog. (return check free of \$25 applies). Prices are subject to change without notice. Cash, Check, Paypal, and Venmo are acceptable forms of payment.

_____6. Do not bring items with your pet that are valuable or irreplaceable. Pineview Pet Boarding, LLC is not responsible for loss or damage to personal items or toys left with your pet. All medications must be in a container with a current prescription label from your veterinarian. Supplements not labeled for animals or prescribed by a veterinarian will only be given with permission and you assume full responsibility for their use.

_____7. Dog food will be administered to dogs that do not bring their own food. The brand is subject to change for kibble but will be a type that is for sensitivity and allergies. The wet dog food brand will be subject to change but will be refrigerated. Changing a dog's food can cause stomach upset. Owners are encouraged to bring their own dog food, bedding, and toys to ensure their dog's comfort. You understand that we cannot guarantee that items will be returned in the same condition.

_____8. We reserve the right to use photographs or video footage of your pet taken during the stay (usually for report card and purposes for owners, or security footage). These images may be used for marketing purposes, either in print form or on the internet.

_____9. You release, indemnify, and agree to hold Pineview Pet Boarding, LLC harmless from any and all manner of damages, claims, loss, and liabilities, costs, or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Pineview Pet Boarding, LLC, except which may arise from the sole gross negligence or intentional and willful misconduct of Pineview Pet Boarding, LLC, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Pineview Pet Boarding, LLC, (ii) you dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.
