In the event that no parent or legal guardian of the Rider can be reached, instructors, agents, and employees of SunCrest Farm are hereby released from all liability with respect to any accidents that might occur. I also understand that SunCrest Farm does not provide accident insurance.

Horseback riding is classified as RUGGED ADVENTURE RECREATIONAL SPORTS ACTIVITY, and there are numerous obvious and non-obvious inherent risks always present in such activity despite all safety precautions. Related injuries can be severe, requiring more hospital days and resulting in more lasting residual effects than injuries in other activities. No horse is a completely safe horse. Horses are 5 to 15 times larger, 20 to 40 times more powerful, and 3 to 4 times faster than a human. If a rider falls from horse to ground, it will generally be at a distance of from 3.5 to 5.5 feet, and the impact may result in injury to the rider. Horseback riding is the only sport where one much smaller, weaker predator animal—the human—tries to control and become one unit of movement with another much larger, stronger prey animal—the horse—with each having a limited understanding of the other. If a horse is frightened or provoked, it may divert from its training and act according to its natural survival instincts, which may include, but are not limited to: stopping short, changing direction or speed at will, shifting its weight from side to side, bucking, rearing, falling, biting, kicking, or running from what it perceives as danger.

I understand that SunCrest Farm is not responsible for total or partial acts, occurrences, or elements of nature that can scare a horse, cause it to fall, or react in some other unsafe way. Some examples are: thunder; lightning; rain; wind; wild and domestic animals, insects, reptiles, which may walk, run, or fly near, or bite or sting a horse or person; and irregular footing on out-of-door groomed or wild land that is subject to constant change in condition according to weather, temperature, and natural and man-made changes in landscape. The parent or legal guardian have inspected the instructional facilities and are satisfied that all premise conditions are reasonably safe for Rider's intended purpose, usage, and presence upon SunCrest Farm.

The undersigned acknowledges the inherent risks involved in riding and working around horses, which risks including bodily injury from using, riding, or being in close proximity to horses, among other risks, and further, that both horse and rider can be injured in normal use or in competition and schooling; and the risks involved in close proximity to bodies of water and the equipment used in fishing and swimming activities.

In consideration for the privilege of (1) riding and/or working around horses at SunCrest Farm and (2) participating in fishing and water activities, the undersigned does hereby agree to hold harmless and indemnify SunCrest Farm and further releases them from any liability or responsibility for accident, damage, injury, or illness to the Rider, the undersigned, or to any family member or spectator accompanying the Rider on the premises of SunCrest Farm.

**COVID-19**

1. SunCrest Farm is taking reasonable precautions to mitigate the risks associated with COVID-19. I understand that such risks cannot be eliminated entirely, as COVID-19 may spread through multiple pathways. I also understand that although reasonable precautions are taken, my child may become infected with COVID-19. I also understand the health risks associated with COVID-19 infection.

2. I expressly agree to accept and assume all risks associated with COVID-19 related to my child's participation in the Camp. I have elected to allow my child to participate in the Camp despite the risks of COVID-19. I recognize that this decision is purely voluntary. I further acknowledge that I have the right to discontinue my child's participation in the Camp at any time.
3. I understand that SunCrest Farm may modify and/or cancel a Camp as a result of COVID-19 issues, or may be directed to modify and/or cancel a Camp by state, county and local authorities.
4. I understand that SunCrest Farm reserves the right to segregate, remove, quarantine, and/or dismiss my child for COVID-19 reasons and/or take all reasonable steps to maintain and protect the health and welfare of my child and other campers, staff, and/or volunteers.
5. I acknowledge that if I decline to allow my child to participate in the Camp, SunCrest Farm will provide a refund of deposit and tuition. I acknowledge that I will remain solely responsible for all other costs incurred in connection with my child's participation in the Camp, including transportation, lodging and incidental costs, even in the event that (a) I elect to discontinue participation in the Camp, (b) SunCrest Farm is required to or deems it necessary to cancel or modify the Camp for COVID-19 reasons, or (c) SunCrest Farm dismisses my child from the Camp for COVID-19 reasons.
6. I accept responsibility for all charges related to any medical treatment or hospitalization in the event my child experiences or exhibits any signs or symptoms of COVID-19 while participating in the Camp.
7. I represent to SunCrest Farm that, to my knowledge, my child (a) has not been diagnosed with COVID-19, (b) has not been exposed to a person presumed or confirmed to have COVID-19 within the fourteen days preceding my child's participation in the Camp, and (c) is free of a COVID-19 diagnosis and any signs and symptoms of COVID-19 (which may include a fever, a dry cough, exhaustion, shortness of breath) as of the first date of my child's participation in the Camp.
8. I agree to accurately and truthfully share all information concerning whether my child has experienced or exhibited any signs or symptoms of COVID-19 or has been presumed or confirmed to have COVID-19. I represent to SunCrest Farm that, if my child has previously been presumed or confirmed to have COVID-19, my child has fully recovered from COVID-19 and has remained free of any signs or symptoms of COVID-19 for at least the thirty days preceding my child's participation in the Camp.
9. I agree to accurately and truthfully share all information known to me or reasonably available to me concerning my child's previous contact with other persons who have been presumed or confirmed to have COVID-19 and/or persons who have experienced or exhibited any signs or symptoms of COVID-19 (which may include a fever, a dry cough, exhaustion, shortness of breath). I acknowledge that I have a continuing obligation to share such information with SunCrest Farm throughout my child's participation in the Camp. I expressly agree to notify SunCrest Farm immediately if I become aware that my child was exposed to a person who has been presumed or confirmed to have COVID-19 and/or persons who have experienced or exhibited any signs or symptoms of COVID-19 (which may include a fever, a dry cough, exhaustion, shortness of breath).
10. ***I HEREBY VOLUNTARILY RELEASE, WAIVE, AND FOREVER DISCHARGE ANY AND ALL CLAIMS AGAINST SUNCREST FARM, LLC, ITS BOARD OF DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS, AGENTS AND ALL OTHER PERSONS OR ENTITIES ACTING ON ITS BEHALF (COLLECTIVELY, "SUNCREST FARM") THAT RELATE IN ANY WAY TO COVID-19, INCLUDING BUT NOT LIMITED TO ANY CLAIM ARISING FROM OR RELATING TO MY CHILD'S EXPOSURE TO, INFECTION WITH, OR OTHER HARM RELATED TO COVID-19 WHILE PARTICIPATING IN THE CAMP AND/OR FOLLOWING PARTICIPATION IN THE CAMP, AND ALSO INCLUDING HARM RELATED TO MY CHILD'S SPREAD OF COVID-19 TO ME AND/OR OTHER FAMILY MEMBERS. I FURTHER AGREE TO REIMBURSE SUNCREST FOR ATTORNEY FEES INCURRED RELATED TO ENFORCING THIS WAIVER PROVISION.***

I agree to indemnify and hold harmless SunCrest Farm from and against any liabilities, claims, causes of action, suits, losses, fines, judgments, settlement, and expenses (including reasonable attorney fees) which may be incurred by SunCrest Farm as a consequence of my child's exposure to COVID-19 resulting in the illness or infection of a third-party.
