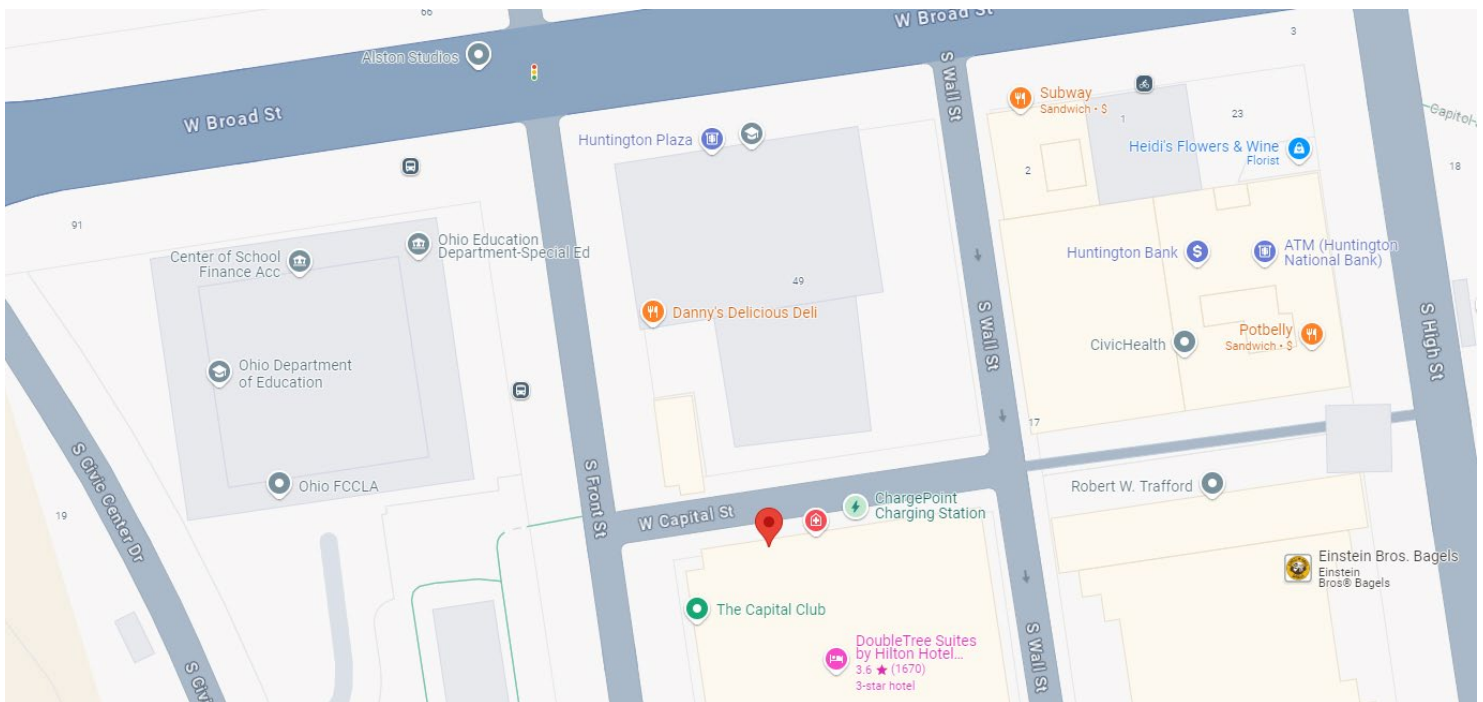

Parking and Access to Conference Space

The meeting will be held at 41 S. High Street, Columbus, OH 43215, however the address for the attached parking garage that is attached to the building is [43 West Capital Street, Columbus, OH 43215](#) (posted fee is \$20 for 5+ hours). Click on the previous address hyperlink or see the map below (red pinpoint). ***NOTE: There will be several spots in the garage that will be reserved for our meeting. If the sign at the garage says "GARAGE FULL," pull up and explain to the parking attendant that you are attending the Air & Waste Association event.*** If that fails, there are other parking garages in the area.

The walkthrough from the attached parking garage to the building is on the 5th floor of the garage. From there walk through the lobby and check in at the guard desk in the center. It is gold.
